## SUMMARY OF YEAR'S ACTIVITIES

### Introduction

The period covered by this report is one of momentous importance in our nation's history. The dominant thought and action of the American people is the successful prosecution of the war in which our country is engaged. The Public Service Commission of Utah has made contributions, at least in a modest way, in this great effort. The construction and operation of several war industry plants in Utah has presented difficult regulatory problems for the commission to handle, especially in the transportation field. Never before in our history has it been necessary to provide transportation facilities for so many people between so many points as has been the case during this period. To help meet the situation the commission has gone to great lengths and has devoted much of its time and effort to develop adequate and suitable facilities, and to effect a correlation of the transportation plant of the state.

Even though the commission sustained a loss to the armed forces and war industries of numerous trained personnel from its staff, it nevertheless embarked upon one of the most important investigations ever initiated in the commission's history. The investigation referred to involves the rates and rate base structure of Utah Power & Light Company.

### Formal Cases Before The Commission

A summary of the number of formal cases before the commission during the period under review is presented in the accompanying Table No. 1.

Case No. 2612

PUBLIC SERVICE COMMISSION OF UTAH, COMP'T.  
vs.

UTAH POWER &amp; LIGHT COMPANY, DEF'T.

A complaint was filed on behalf of the commission in August, 1942, alleging that the rates of Utah Power & Light Company are unjust and unreasonable and that said defendant is and has been earning in excess of a reasonable return on a just and proper rate base in rendering electric service in the State of Utah. The complaint ordered that an investigation and public hearing be had to determine a just and proper rate base and a fair and reasonable rate of return on such base, and to inquire into the justness and reasonableness of the defendant's rates.

Hearings were commenced in November, 1942, and were concluded in February, 1943. The hearings covered a total of thirty-six days. The transcript numbers 3,629 pages and a total of 126 exhibits were introduced, 78 by the commission's staff and 48 by the defendant company. Main and reply briefs were filed.

The commission was very fortunate in securing the services of experts of the Federal Power Commission to assist in the preparation of exhibits and in the presentation of the case. The commission is deeply grateful to the Federal Power Commission for making these men available for the case.

At June 30, 1943, the case had been submitted to the commission for its consideration and decision but a report and order had not been completed.

**Telephone Rates**

Case No. 2503

PUBLIC SERVICE COMMISSION OF UTAH, COMP'T.

vs.

THE MOUNTAIN STATES TELEPHONE AND  
TELEGRAPH COMPANY, DEF'T.

This investigation was brought to a conclusion by the issuance of a report and order on September 18, 1942, whereby the defendant telephone company was ordered, effective 12:01 a. m., October 18, 1942, to reduce such of its Utah intrastate message toll telephone rates for all rate-mile distances over 16 miles as exceed the rates charged and collected by it for corresponding interstate toll service, rendered jointly by it and the American Telephone and Telegraph Company from and to points within the state of Utah, to the level of such interstate rates. The defendant also was ordered to discontinue the making and collection of report charges on uncompleted intrastate message toll telephone calls.

The defendant company filed a petition with the Supreme Court of Utah on October 14, 1942, for a review of the commission's order. The order of the commission was stayed by the court and the defendant telephone company was required to post a bond and impound in a Salt Lake City bank until final decision in the case the amounts of money collected on intrastate toll calls in excess of that which would have been collected under the level of rates prescribed by the commission.

At the closing date of this report the court had not rendered an opinion in the case.

**Investigation Dockets**

Orders were issued in three investigation dockets as shown by Table No. 15, Appendix II.

Investigation Docket No. 22 involved a proposal of Mountain Fuel Supply Company to abandon and withdraw its Class VII industrial rate applicable for use as fuel only in reverberatory furnaces and copper ladles of smelters. The company had only three customers taking service under this rate. Following an investigation and hearing the commission denied the company's application to abandon this rate.

A penalty of \$1,000 was imposed upon Telluride Power Company by the commission in Investigation Docket No. 34 by an order dated April 29, 1942. This penalty was assessed against said company for its failure to comply with the commission's orders relative to the reclassification and original cost of its utility plant. The company applied for an extension of the effective date of the order to September 1, 1942, which was granted. The effective date of the order was extended indefinitely by a further order issued on September 3, 1942.

The issues involved in Investigation Docket No. 40 resulted in litigation in the Supreme Court of Utah. The matter is discussed below in the section on cases on review in the Supreme Court.

### Special Permissions

The commission issued 175 special permissions to the railroads, motor carriers, and other utilities under its jurisdiction. Reductions in rates were authorized in 101 of these orders. A summary of the special permissions issued may be found in Table No. 16, Appendix II.

### Informal Dockets

Orders were issued in sixteen informal dockets. Table No. 17, Appendix II, shows a summary of these orders.

### War Service Orders

Conditions and circumstances incident to the war formed the basis for the issuance of twelve "War Service Orders." The authority conveyed under orders of this nature is limited, ordinarily, to a period not exceeding six months after the duration of the war. The subject matter of the war service orders is covered by Table No. 18, Appendix II.

### General Orders

Only one general order was issued during the period. This order (General Order No. 55) authorized the honoring by carriers of tickets and baggage checks held by passengers when such tickets or baggage checks have been issued by other carriers, either rail or motor.

## Transportation Rates

### I. C. C. I. & S. Docket No. 5091 RATES ON VEGETABLES FROM INTERMOUNTAIN TERRITORY TO EAST AND SOUTH

By schedules filed to become effective December 29, 1941, The Denver and Rio Grande Western Railroad Company, Union Pacific Railroad Company and other railroads published rate increases applicable on onions, lettuce, peas, celery and other vegetables from the Intermountain territory to Eastern and Southern states.

Upon protest of this commission and the Public Utilities Commission of the State of Idaho, the Interstate Commerce Commission suspended the new schedules until July 29, 1942 and the case was set for hearing at Boise, Idaho March 31, 1942. Hearing was postponed and the effective date of schedules was further suspended to January 29, 1943, due to prospect of favorable settlement between protestants and carriers.

By agreement between interested parties to complaint, proposed increases were withdrawn and suspension lifted except insofar as it was applicable to leafy vegetables, viz.: lettuce, green peas, carrots, celery and cabbage, and hearing was set for June 7, 1943. Carriers voluntarily postponed operation of increased schedules until after hearing could be held.

Hearing was held in Boise, Idaho between interested parties June 30, 1943 and agreement reached whereby carriers would publish and make applicable the lowest combination of rates. This resulted in no increase and many reductions.

### I. C. C. Finance Docket No. 13771 UNION PACIFIC PROPOSAL TO ABANDON FILLMORE BRANCH

On June 1, 1942, application was made by the Los Angeles & Salt Lake Railroad Company and the Union Pacific Railroad Company for a certificate of public convenience and necessity permitting abandonment by the former and abandonment of operation by the latter of the branch line extending from Delta to Fillmore, Utah, approximately 31.24 miles in Millard County, Utah.

Protest was entered by this commission in behalf of the citizens of Millard County through which the railroad was operated and the Interstate Commerce Commission ordered hearing held in Salt Lake City, Utah, August 25, 1942.

Attorney for the applicant at hearing asked for indefinite postponement of the hearing but upon objection by Commerce Attorney of this commission, supported by attorney for Millard County, the Interstate Commerce Commission dismissed the application.

P. S. C. U. I. & S. Docket No. 32  
ROCK DUST

By tariffs published and filed to become effective September 24, 1942, the Union Pacific Railroad Company proposed to increase rates on rock dust, minimum weight 80,000 pounds, from Devils Slide, Utah, to Kingmine, Utah, coal mining districts from \$3.00 per net ton to \$3.30, and from Midvale and Salt Lake City, Utah, to the same destinations from \$2.00 per net ton to \$2.20.

Upon protest of the Utah Coal Operators Association, operation of the said increases was suspended by the Public Service Commission of Utah until December 21, 1942.

Hearing held in the offices of this commission December 7, 1942, resulted in finding by the commission that the proposed increases, suspended in this matter, were not justified and should be cancelled and respondents were so ordered.

P. S. C. U. I. & S. Docket No. 34  
FURNITURE AND FURNITURE PARTS

By tariffs published and filed to become effective January 14, 1943 on both interstate and intrastate traffic, the Union Pacific Railroad Company proposed to increase the rates on furniture and furniture parts from California points to Utah and between certain points within the State of Utah by elimination from Item No. 2538-1-E, Tariff No. 7020, covering list of articles taking commodity rates provided for "General Merchandise" thereby making class rates applicable.

This commission suspended the increases on Utah intrastate traffic and similar action was taken by the Interstate Commerce Commission on protest of Office of Price Administration pending hearing set for January 28, 1943, to determine the reasonableness of the said proposed rates.

Before date of hearing the Union Pacific Railroad Company requested and was granted special permission authority on January 20, 1943 to restore furniture and furniture parts to Item 2538-1-E.

I. C. C. I. & S. Docket No. 5183  
BREAD AND CAKE

By schedules filed to become effective January 20, 1943, the Railway Express Agency proposed to increase rates on bread, cake and bakery goods from Salt Lake City and Ogden, Utah, to over 100 points in Idaho, Montana, Oregon, and Wyoming in amounts ranging from 21 to 61 per cent, averaging about 35%.

The commission protested the increases and the Interstate Commerce Commission suspended the said increases until August 20, 1943, and ordered hearing set for March 29, 1943, at Salt Lake City, Utah.

Hearing was ordered cancelled February 23, 1943, as respondents under special permission issued by the Interstate Commerce Commission filed tariffs cancelling the increases under suspension. Had these increases been allowed, Utah bakeries would have been unable to supply scores of cities and towns in Idaho, Oregon, Montana, and Wyoming with fresh bread, cake, etc., for the duration as no other form of transportation was available.

CASES ON REVIEW IN THE  
SUPREME COURT OF UTAH

UNION PACIFIC RAILROAD COMPANY, OGDEN CITY, and THE UTAH IDAHO CENTRAL RAILROAD CORPORATION, Plaintiffs, vs. PUBLIC SERVICE COMMISSION, OF UTAH, Defendant.

(Supreme Court No. 6556)

The commission issued an order on September 26, 1942 in Investigation Docket No. 40, ordering an investigation into the facts and circumstances relating to the proposed discontinuance of spur track service of Union Pacific Railroad Company and The Utah Idaho Central Railroad Corporation on Second Street in Ogden, Utah. After denying a motion of these two railroad companies and Ogden City to dismiss the proceeding, and after the overruling of a demurrer of the same parties, a petition for a writ of prohibition was filed in the Supreme Court by the plaintiffs named above. Under date of February 26, 1943, the court granted a permanent writ. In the course of its opinion, the court stated:

"Since the legislature has granted to cities and towns the power to control the use and occupancy of their streets to the extent as hereinbefore set forth, and has never expressly granted it to the commission; and since those powers have never been repealed either expressly or by implication, but on the other hand, within the limits of the issues here presented, may be construed so as to give effect both to

them and to the provisions of the Public Utility Act; and since within the purview of the foregoing the Commission in initiating its said proceeding of September 28, 1942, designated as "Investigation Docket No. 40," was acting without and in excess of its jurisdiction, it is ordered that the alternative writ of prohibition heretofore granted by this court be made permanent."

**UNION PACIFIC RAILROAD COMPANY, Plaintiff, vs.  
PUBLIC SERVICE COMMISSION OF UTAH, Defendant  
(Supreme Court No. 6558.)**

An application of Union Pacific Railroad Company in Case No. 2579 for permission to discontinue its station at Lehi, Utah, as an agency station was denied by the commission on August 21, 1942. Union Pacific Railroad Company petitioned the Supreme Court for a writ of certiorari. By stipulation, the case was dismissed by the court on February 1, 1943.

**UNION PACIFIC RAILROAD COMPANY, Plaintiff, vs.  
PUBLIC SERVICE COMMISSION OF UTAH, Defendant  
(Supreme Court No. 6474)**

This case involved a review of an order of the commission in Case No. 2496 wherein Union Pacific Railroad Company was denied authority to discontinue certain train service in the State of Utah. The court's opinion handed down on December 12, 1942, reversed the commission. Accordingly, the commission issued an order on January 27, 1943, authorizing Union Pacific Railroad Company to discontinue the passenger train service involved in this case.

The case brought by The Mountain States Telephone and Telegraph Company involving the validity of an order of the commission reducing the intrastate toll rates of said telephone company was discussed above in the section on telephone rates.

**Costs of Operation of Commission**

The commission expended a total of \$84,617.80 during the fiscal year ended June 30, 1943, in administering the laws for which it is responsible. \$75,845.93 of this amount was expended from the commission's general fund appropriation and \$8,771.87 was used out of the motor transport fund appropriation.

Further details of these expenditures are contained in Table No. 20, Appendix II.
