#### SECTION I

#### FORMAL CASES BEFORE THE COMMISSION

During the fiscal year ended June 30, 1958, the Commission disposed of 181 formal cases, compared with 168 in the previous period. At June 30, 1958, there were seven cases pending that had been heard and submitted, and 33 cases on file that had not been heard or otherwise acted upon. The latter group includes several applications for interstate motor carrier authority in Utah that cannot be disposed of until the Interstate Commerce Commission acts upon applications from the same carriers; a number of cases filed too late in the fiscal year to arrange hearings; and others the disposition of which has been delayed due to circumstances peculiar to each proceeding. A general summary of the formal cases is shown in Table No. 1, Appendix I, and digests of the orders issued by the Commission are contained in Tables 2 to 18, inclusive.

#### **Electric Rates**

There were no changes in the rate structures of the six electric utilities operating in Utah during the period of this report.

#### Gas Rates

Utah Gas Service Company was authorized in an order dated September 25, 1957, Case No. 4504, to increase its rate for interruptible industrial gas service by .36 cents per therm. This increase was allowed to offset a comparable increase in the rate charged by Pacific Northwest Pipeline Corporation for natural gas supplied to the Utah Gas Service Company for resale to industrial interruptible customers.

An order issued February 14, 1958, in Case No. 4552, permitted Utah Gas Service Company to increase its rate for domestic and commercial uses by approximately 3 per cent. This adjustment also was authorized to meet an increase in the rate of Pacific Northwest Pipeline Corporation which became effective February 5, 1958. The order provides, however, that if at some future date the Federal Power Commission requires Pacific Northwest Pipeline Corporation to refund to Utah Gas Service Company a part or all of the difference between the prior and present rate, the Utah Gas Service Company shall make appropriate refunds to its customers in a manner to be approved by the Commission.

Mountain Fuel Supply Company has been purchasing a part of its natural gas requirements from Pacific Northwest Pipeline Corporation since November 1, 1956. The latter named company filed increased rate schedules with the Federal Power Commission in August, 1957, and the particular schedule under which Mountain Fuel purchases gas was allowed to become effective on February 5, 1958. The effect of the higher rate was an increase in the cost of gas purchased by Mountain Fuel from the Pacific Company of not less than \$1,058,000 annually for the minimum quantity of 50,000 Mcf per day specified in the purchase agreement. Mountain Fuel filed an application with the Commission for permission to increase its

rates in an amount sufficient to offset the increase in the rate of the Pacific Company. An order issued under date of February 28, 1958, in Case No. 4555 authorized Mountain Fuel to file a new schedule of rates containing "offset charges" to accomplish this purpose. The order contains a proviso that in the event of a refund from the Pacific Company after the rates of such company have been finally fixed and determined by the Federal Power Commission, Mountain Fuel shall submit a computation showing the amounts refundable to its customers following which an appropriate refund order will be entered by the Commission. The offset charge assigned to the firm classifications of service of Mountain Fuel such as domestic and commercial represents an average increase to users of 4.25 per cent, while the increase assigned to interruptible classifications averaged 3.07 per cent.

### **Telephone Rates**

A proceeding instituted by the Mountain States Telephone and Telegraph Company in January, 1956, to increase its Utah Intrastate telephone rates was concluded by an order issued by the Commission on January 31, 1958. The first phase of the hearing in this matter (Case No. 4220) extended over the period from the latter part of March, 1956, to June 12, 1956. On July 2, 1956, the Mountain States Company filed a petition to reopen the case for further hearing at a future date to be determined. The company filed a motion with the Commission on September 27, 1957, requesting that a date for such further hearing be set. Further hearing was held during December, 1957, and the case was finally submitted. In connection with this case the Commission engaged the services of Dr. Lionel W. Thatcher, professor of transportation and public utilities at the University of Wisconsin, to present evidence as a staff witness on the subject of cost of capital and fair rate of return, and the services of Lincoln G. Kelly and Company, a Salt Lake City firm of certified public accountants, to make a review of the exhibits, accounts, and accounting procedures of the company.

The Commission's order of January 31, 1958, authorized the Mountain States Company to file a new schedule of rates designed to increase its Utah intrastate gross revenues by not more than \$1,936,458 when applied to the estimated average number of telephones during 1958 of 297,997 and the volume of business projected for that year.

Millard County Telegraph and Telephone Company was granted authority in an order dated October 24, 1957, to revise its basis of computing toll charges on messages between points on its own system. Prior to this change and since February 1, 1920, toll charges on intracompany toll messages had been based upon circuit route mileage. The Commission authorized the company to change to an airline basis of fixing toll charges which method is in general use throughout the United States. The mileage steps and rates adopted are the same as those currently in use by The Mountain States Telephone and Telegraph Company. The change resulted in both increases and decreases in toll charges with a preponderance of reductions.

An application of Midland Telephone Company for an increase in local exchange rates was heard by the Commission at Moab, Utah, on April 28, 1958. The application was denied in an order issued June 12, 1958.

#### Railroad Rates Intrastate

The two previous reports contained information on the matter of the Section 13 proceeding, Docket No. 31484, before the Interstate Commerce Commission. In this case the Interstate Commerce Commission ordered the railroads operating in Utah to apply a 15 per cent increase intrastate in Utah, comparable to that applicable in interstate commerce as a result of Ex Parte 175 proceedings.

The public Service Commission of Utah and the Utah Citizens' Rate Association filed a complaint in the Three Judge Federal District Court for the state of Utah, which court, with one judge dissenting, upheld the Interstate Commerce Commission's order. The matter was appealed to the United States Supreme Court, which court heard oral argument on December 9, 1957. The Utah Commission was represented in argument by its commerce attorney, and counsel for Utah Citizens' Rate Association appeared on behalf of that organization. On May 19, 1958, the Supreme Court rendered its decision in favor of the appellants, Public Service Commission of Utah and Utah Citizens' Rate Association, reversing the judgment of the District Court heretofore entered and remanding said cause to that court with instructions to set aside the order of the Interstate Commerce Commission. At the close of this report period further proceedings were pending, both before the Federal District Court and the Interstate Commerce Commission, to have the increase set aside.

On February 12 and 13, 1958, a hearing was held by the Interstate Commerce Commission pursuant to a Section 13 proceeding, Docket No. 32253. The Utah railroads were requesting an increase of about 18 per cent on Utah intrastate freight rates, comparable to those already granted in Interstate Commerce Commission proceedings Ex Parte 196 and Ex Parte 206. The railroads, as respondents, offered evidence to support the increase. Counsel for Utah Citizens' Rate Association and for the Public Service Commission of Utah appeared as protestants. Thereafter briefs were filed by both protesting parties. The Interstate Commerce Commission had not issued a proposed report and order by the close of this report period.

# Express Rates

Orders were issued in three cases in which Railway Express Agency, Incorporated was authorized to make tariff changes resulting in both increases and decreases in Utah intrastate rates. Each case was concerned with specific tariff items or provisions only. The general rate structure of this company was not involved.

# **Urban Passenger Carrier Rates**

Salt Lake City Lines sought authority by formal application to eliminate tokens for adult riders; to eliminate weekly passes; to increase children's fares both in the base zone and in additional zones from 5 cents to 10 cents; to eliminate student tokens or tickets;

and to restrict the use of student fares to grade school and high school students.

The Commission engaged Birrell, Zimmerman & Thomas, a Salt Lake City firm of certified public accountants, to make a study of certain aspects of the operations of Salt Lake City lines with particular reference to the relationship between that company and its parent, National City Lines. An examination was made of certain records and procedures of National City Lines at its office in Chicago, Illinois, as well as a review at Salt Lake City of the accounting records and procedures of Salt Lake City Lines. A member of the Commission's staff collaborated in the study. The written report of this accounting firm was submitted at the hearing in this matter.

The commission's order in this case dated April 26, 1958, contained the following provisions:

- (A) The presently existing fares and charges of City Lines shall remain in full force and effect unless and until modified by further order of the commission.
- (B) City Lines shall not reduce or curtail any schedule without express authorization of the Commission.
- (C) City Lines shall divest itself of its interest in National City Truck Rental Company represented by a loan to that company.
- (D) City Lines shall replace its older passenger carrying coaches with new equipment and shall expend for this purpose in the immediate future an amount not less than that represented by the notes of National City Truck Rental Company held by City Lines.
- (E) City Lines shall advise the Commission promptly in writing of the declaration of each dividend on its capital stock in the future, and shall not pay any dividend except upon written approval of the Commission.
- (F) City Lines and the staff of the Commission shall make depreciation studies in respect to structures and improvements for the consideration of the Commission to determine if the unrecovered balance in the structures and improvements account should be extended beyond a 20 years' life for the purpose of annual depreciation charges, the results of such studies to be submitted in writing to the Commission within 90 days of the date of this order.
- (G) City Lines shall continue to furnish the Commission with monthly reports showing operating figures and miles traveled.

#### **Motor Carrier Rates**

Orders were issued in 20 cases in which the rates of motor carriers were involved. Increases in rates for transportation of property were allowed in eight cases; increased passenger fares were granted in four cases; a change in the minimum weight rule was approved in one case; authorization was given in one case to republish

one of the principal intrastate motor freight tariffs including changes in some items and elimination of others resulting in both increases and decreases in rates, the main purpose being a simplification of the tariff in question; and six cases concerned with rates on property were dismissed. In addition, a supplemental order in a case closed in a prior period was issued granting an increase in a commodity rate. A summary of these orders is shown in Table No. 7, Appendix I.

# **Motor Carrier Operating Authority**

The following tabulation shows a summary of the action taken by the Commission in cases involving motor carrier operating authority in the state of Utah during the fiscal year ended June 30, 1958.

#### Natural Gas Service In New Areas

Mountain Fuel Supply Company was granted a certificate of convenience and necessity on July 3, 1957, (Case No. 4466) to construct and operate as a part of its distribution system in the state of Utah an extension northward from Ogden through Brigham City into Logan for the purpose of serving natural gas for domestic, commercial, and industrial uses in Brigham City and Logan. The residents of Brigham City and Logan had natural gas service available for the first time during the winter season of 1957-58. During December, 1957, a total of 1,119 customers received gas service in the Brigham City—Logan areas. By June, 1958, the number had increased to 2,411.

Utah Gas Service Company, a distributor of natural gas in Vernal, Moab, and Monticello, Utah, was granted a certificate of convenience and necessity on April 25, 1958, to construct and operate a natural gas distribution system for the purpose of distributing natural gas to the inhabitants of Flaming Gorge Community and others at the Government Camp in Daggett County, Utah. The source of supply of the natural gas to be distributed in this area is the 26-inch transmission pipeline of Pacific Northwest Pipeline Corporation which crosses a portion of Daggett County within 1,500 feet of the Townsite and  $1\frac{1}{2}$  miles from the site of Flaming Gorge Dam on Green River.

# Utah Power & Light Company Acquisition of Telluride Power Company Securities

The Commission granted authority to Utah Power & Light Company under date of February 24, 1958, (Case No. 4553) to acquire the common stock and second preferred stock of Telluride Power Company owned by six stockholders, who, as a group, held in excess of 80 per cent of the common and preferred stock of Telluride. The

order also provided that Utah Power & Light Company could extend an offer to all other holders of the common and second preferred stock of Telluride to acquire their stock. The two major stockholders of Telluride were educational foundations known as the Telluride Association and Trustees of Deep Springs. The initiative for the proposed transaction came from the president of Telluride and primarily on behalf of the two largest stockholders who desired to divest themselves of the responsibility and problems inherent in the ownership of the controlling interest in Telluride.

The systems of the two companies have been physically interconnected for many years and approximately 80 percent of the electric energy requirements of Telluride is provided by Utah Power & Light Company. After acquisition of the securities of Telluride covered by the transaction, Telluride will be operated as a subsidiary of Utah Power & Light Company.

# Merger of Southern Utah Power Company Into California-Pacific Utilities Company

Southern Utah Power Company as a separate and distinct electric utility has ceased to exist by reason of its merger with and into California-Pacific Utilities Company, authorized by the Commission by formal order in Case No. 4585 dated May 27, 1958. The area served by Southern Utah Power Company in Utah is in Iron and Washington Counties and Kanab, Kane County. The community of Fredonia, Arizona, also obtained electric service from the same company. California-Pacific Utilities Company owns and operates electric systems in certain communities in California, Oregon, Nevada, Idaho, and Wyoming. It also provides gas, water, and telephone service in certain areas.

#### SECTION II

#### GENERAL AND MISCELLANEOUS

### Special Permissions

The Commission issued 80 special permissions authorizing tariff changes on less than the statutory notice of 30 days. Reductions in rates, corrections of tariff errors, the establishment of rates for new services, etc., were covered by these orders. Table No. 19, Appendix II, contains a summary of these orders.

#### Informal Dockets

Four informal dockets were closed. The subject matter of these proceedings is shown in Table No. 20, Appendix  $\Pi$ .

### **Investigation Dockets**

Orders were entered in two investigation dockets, as shown by Table No. 21, Appendix II. One of these involved the rate for electric power furnished Parowan City by Southern Utah Power Company, and the other was concerned with the right of two motor carriers to provide service in the area of another carrier.

### Investigation and Suspension Dockets

Two investigation and suspension dockets involving motor carrier rates and one which was concerned with rates for accessorial services by railroads operating in Utah were concluded. The orders in these matters are described in Table No. 22, Appendix II.

#### General Orders

Six general orders were issued dealing with such subjects as rules and regulations for gas utilities; the regulation and registration of motor carriers operating under the exempt provisions of the motor carrier act; insurance requirements for motor carriers; accounting and report requirements for motor carriers; and regulations for the preservation of records of electric utilities. These orders are summarized in Table No. 23, Appendix II.

#### **Commission Finances**

During the fiscal year ended June 30, 1958, the Commission expended \$116,161.12 in the administration of the public utility regulatory laws of Utah. Table No. 24, Appendix II, contains additional information concerning the appropriations and expenditures of the Commission.

# Joint Board Hearings

One of the Commissioners or a staff member sat in 22 joint board hearngs on applications of motor carriers for operating rights interstate under the Federal Motor Carrier Act. Three of these hearings were held in Boise, Idaho; one in Denver, Colorado; and the balance in Salt Lake City.

# Review of Commission Orders By Supreme Court of Utah

Robert L. McMullin, et. al., vs Public Service Commission of Utah, et. al. (Supreme Court No. 8660)

Plaintiffs sought an order from the Commission to require Union and Jordan Irrigation Company to provide water for culinary purposes at a location beyond the service area of the water company. The Commission denied the petition (Investigation Docket 69). The court affirmed the order of the Commission on February 3, 1958. 7 Ut. 2nd 157.

Neal R. Morris, et. al., vs.
Public Service Commission of Utah, et. al.
(Supreme Court No. 8698)

An order of the Commission (Case No. 4294) canceled the certificate of convenience and necessity held by Robert W. Watson, dba Bob Watson Moving; and denied the application of Neal R. Morris, dba Martian Delivery Service, for a certificate to operate as a common motor carrier of household goods, assuming the rights of Robert W. Watson. In its opinion dated February 13, 1958, the Supreme Court ruled that the order of the Commission should be set aside on the ground that the Commission acted without authority in canceling the certificate when no notice had been given that the question of canceling the certificate would be considered at the hearing. 7 Ut. 2nd 167.

Subsequently, after reconsideration of the record and in conformity with the opinion of the Supreme Court, the Commission entered an order on June 28, 1958, in which it issued a certificate of convenience and necessity to Neal R. Morris, dba Martian Delivery Service, authorizing him to assume the common carrier operating rights covered by the certificate held by Watson.

#### Interstate Commerce Commission Cases

The Public Service Commission of Utah filed a petition for a suspension of certain interstate rates on fresh meat and packing house products. The petition was prepared by the Commission's commerce attorney and was submitted on August 1, 1957, on behalf of the Commission, Utah State Department of Agriculture, Salt Lake City Chamber of Commerce, Utah Wool Growers' Association, and Utah Cattlemen's Association. The Commission did not participate in any further proceedings in the matter during this report period.

The Utah Commission also filed a petition for the suspension of certain interstate rates on lead, zinc, and zinc-alloy products, published in the Canadian Pacific Railway Tariff No. 116-L, Supplement No. 5. The rates published were so low that it appeared they might seriously affect production and marketing of Utah lead and zinc products. This petition was prepared by the commerce attorney for the Commission and was submitted on August 28, 1957. The Commission did not participate further in the matter during the year covered by this report.

#### SECTION III

#### SELECTED DATA ON UTILITY OPERATIONS

#### Electric Service and Trend of Electric Rates

The average annual use of electricity in Utah by residential customers of the six privately owned electric utilities in 1957 amounted to 3,878 kilowatt-hours, an increase of 121 kilowatt-hours over the 1956 figure. While the average cost to the customer per kilowatt-hour remained at 2.21 cents, the same as in 1956, the higher usage increased the average annual residential bill to \$85.53 compared with \$82.97 in 1956. The trend over a period of years in the cost to the customer and use of electricity in Utah is shown below.

### Telephone Service

The 17 telephone utilities operating in Utah During 1957 had 298,524 company-owned telephones in service as of the end of that year, of which number 255,808 were served by automatic dial equipment, 42,353 were of the common battery manual type, and only 248 were the old style magneto manual type. The total figure also includes 115 mobile telephones. During 1957, the Mountain States Telephone and Telegraph Company converted to dial operation its last two magneto manual offices in the state of Utah which were located at Panguitch and Kanab, and most of the subscribers of Millard County Telegraph and Telephone Company in Fillmore were transferred from magneto manual to common battery manual service.

The following figures show the telephones in service in Utah at December 31, 1957, by the principal service classifications.

NUMBER OF TELEPHONES IN UTAH

In addition to the stations owned by the telephone utilities, there were in service in Utah on December 31, 1957, 5,782 stations classified as service telephones and 646 stations classified as private line telephones. These telephones are served by The Mountain States Telephone and Telegraph Company but are owned by the United States Government and other organizations or groups.

#### Gas Rates and Use of Natural Gas

There are two natural gas distributing companies operating in Utah, Mountain Fuel Supply Company and Utah Gas Service Company. During 1957, the residential and commercial customers served by these utilities averaged 136,165 in number and 388 industrial customers received service. The number of industrial accounts dropped considerably during 1957 over 1956 due to the elimination of a low

load factor industrial rate from the tariff of Mountain Fuel Supply Company and the transfer of most of the customers thereunder to the general service rate.

The data in the following table are presented to show the trend since 1940 in average annual use of gas by residential and commercial customers and the cost of gas to the customer.
