SECTION I

General Summary

Introduction

The Commission issued 256 orders in formal cases and 80 orders in other proceedings during the fiscal year ended June 30, 1962. The various matters covered by these orders are summarized in a brief form in the tables contained in Section 3 of this report.

Electric Rates and Service

The rates and charges of the electric utilities in the state of Utah remained unchanged during the period of this report. In an order dated March 1, 1962, the Commission authorized Wendover Light and Power Company to discontinue service in Wendover, Utah and vicinity. Wells Rural Electric Company acquired the properties of this company and is now providing electric service in Wendover.

Utah Power & Light Company was authorized by the Commission in an order issued May 4, 1962, to acquire the property and assets of Swan Creek Electric Company in Rich County, Utah. The actual transfer of the properties to Utah Power & Light Company did not occur until September 1962.

Gas Rates and Service

There are two natural gas pipeline companies in Utah, including Mesa Pipeline Company referred to below, which transmit natural gas from producing fields to a point of connection with a distributing company. There are two utilities, Mountain Fuel Supply Company and Utah Gas Service Company, which distribute and sell natural gas to the general public in their respective service areas. There were no changes in the rates of these utilities during the fiscal year ended June 30, 1962.

The Commission issued a certificate of convenience and necessity to Mesa Pipeline Company, a corporation, on June 21, 1962, for the construction and operation of approximately 52 miles of 1234 inch outside diameter pipeline, together with related gathering, compressor, and other facilities. The pipeline will transport natural gas from gas reserves in the Book Cliffs area of mid-eastern Utah to a point of connection with the 20 inch natural gas transmission line operated by Mountain Fuel Supply Company in the Island Unit of the Uintah Basin in eastern Utah. All of the gas to be moved through this pipeline will be sold to Mountain Fuel Supply Company at the point of interconnection in the Island Unit, pursuant to contractual arrangements. The proven recoverable gas reserves are in formations underlying the San Arroyo and Bryson Canyon Units in the Book Cliffs area, and are calculated at 368,500,000,000 cubic feet by geological and petroleum engineering calculations. A gas reserve of this magnitude is equivalent to an average production of 50.5 million cubic feet of gas per day for 20 years. The drilling of additional wells in the area is contemplated in the future and it is expected that the gas reserves will increase as new wells are brought into production.

Telephone Rates

Early in 1962 the Committee on Communications Problems of the National Association of Railroad and Utilities Commissioners reached an accord with the Federal Communications Commission relative to certain changes in the standard procedures and practices for the separation of telephone plant and expenses between intrastate and interstate business. The changes agreed upon resulted in a net transfer of approximately \$46 million in revenue requirements from the intrastate to the interstate operations of the Bell System. The amount assignable to Utah intrastate operations was \$347,480 based on October and November 1961 traffic and expense data. The Commission requested The Mountain States Telephone and Telegraph Company to reduce its charges for Utah intrastate toll service by this amount. Following several conferences with the Commission's staff the company filed revised tariff sheets designed to produce annual reductions in revenue of the amounts shown below by category of service.

The new message toll rates provide reductions in each class of service for most rate mileage steps in excess of 40 (airline) miles. A substantial part of the \$240,900 decrease in toll rates was assigned to initial period rates for station-to-station full rate (day) service. The new rates became effective on May 1, 1962.

The Commission issued its findings and an order on December 22, 1961, on an application of Millard County Telegraph and Telephone Company for authority to increase its rates and charges. The Commission authorized a substantial general increase in the rates of this telephone utility, the first one granted in 40 years. This utility provides a general telephone service in Millard County, Utah.

Uintah Basin Telephone Association, Inc., was authorized to increase its monthly rates by 50 cents for each class of service to subscribers in Tabiona and Randlett. This increase was authorized in connection with the establishment of extended area service between Tabiona and Duchesne and between Randlett and Roosevelt. The exchanges at Duchesne and Roosevelt are operated by The Mountain States Telephone and Telegraph Company. Manti Telephone Company also was permitted to increase its monthly rates for each class of service by 50 cents at the time extended area service was established between Manti and Ephraim.

Express and Railroad Rate Cases

Three orders were issued in which Railway Express Agency, Inc., was authorized to make changes in its tariff resulting in technical increases in rates, and in one order the same company was authorized to add an additional charge of 10 cents for each LCL shipment with certain exceptions.

The Commission issued orders in five cases involving railroad rates in two of which technical increases were authorized in freight rate classification and rules. A five per cent increase in the basic passenger fares of the four principal railroad companies operating in Utah also was approved.

Local Transit Rates

The Commission authorized Salt Lake City Lines to increase its adult fares to 20 cents cash and tokens 3 for 50 cents in an order dated February 19, 1962. The same order allowed the child's cash fare to be increased from 5 cents to 10 cents and the weekly pass from \$2.75 to \$3.00. Salt Lake City Lines is faced with the same basic problem as many of the transit companies in the United States, namely, a continuous loss of riders. There are numerous factors which contribute to the downward trend of passengers but the principal one is the greater use of private automobiles.

Motor Carrier Rates

The Commission issued 25 orders dealing with intrastate rates of carriers by motor vehicle. The various problems and situations involved in these proceedings are briefly summarized in Table 4.

Station Agency Cases

The Denver & Rio Grande Western Railroad Company was authorized to close its agency station at Layton, Utah and also the one at Eureka, Utah. Union Pacific Railroad Company was permitted to discontinue its station at Black Rock, Utah as an agency station but was required to continue it as a non-agency station. In another proceeding the application of Union Pacific Railroad Company to close its agency station at Lehi was denied.

Grade Crossing Cases

The Commission issued 34 orders dealing with grade crossings in the state of Utah. These cases involved such matters as the establishment of new highway grade crossings, the abandonment of existing grade crossings, the widening of grade crossings, the construction of overpass structures, and other crossing situations which occur in connection with the highway construction program in the state of Utah. A summary of these orders may be found in Table 6.

The Commission issued General Order 86 on January 22, 1962, in which it established standards, regulations, and procedures under which authority may be granted to remove the requirement for a complete stop at a railroad crossing by common carriers by motor vehicle.

Section 41-6-97, Utah Code Annotated 1953, requires the driver of every motor vehicle transporting passengers, school children, explosives, flammable substances, or corrosive liquids, before crossing at grade any track or tracks of railroads, to stop the vehicle within 50 feet but not less than 10 feet from the nearest rail of such railroads and not to proceed over the crossing until he can do so safely. Paragraph (c) of the statute referred to provides that "Unless a railroad train is approaching, any vehicle listed (as herein described) may proceed without stopping, but at a speed not exceeding twenty five (25) miles per hour, at any highway grade crossing of a railroad where a distinctive sign is displayed indicating that the Public Service Commission of Utah, after hearing, has approved that no stop need be made."

Motor Carrier Authority

Digests of the action taken by the Commission in orders dealing with motor carrier operating rights are contained in Tables 8 to 14. A summary of these orders is shown in the following tabulation:

Special Permissions

The Commission issued 73 special permissions the majority of which authorized tariff changes on less than the statutory notice of 30 days. Table 17 contains a summary of these orders.

Informal Dockets

The Commission disposed of four informal dockets, two of which authorized refunds to shippers of freight. The other two proceedings granted modifications of the Commission's regulations dealing with clearances on railroads. A summary of these orders is presented in Table 18.

Investigation Dockets

Orders were issued by the Commission in nine investigation dockets. Most of these dockets were concerned with various features of the operations of motor carriers. In Investigation Docket No. 91 the Commission ordered The Mountain States Telephone and Telegraph Company to file a new tariff reducing its Utah intrastate toll service rates. This matter has been referred to before in this report. Table 19 contains digests of these orders.

Investigation and Suspension Dockets

The Commission disposed of six investigation and suspension dockets. These proceedings dealt largely with proposed tariff changes by intrastate motor carriers in Utah. A summary of these orders may be found in Table 20.

General Orders

There were four general orders issued involving accounting regulations applicable to electric, gas, water, and telephone utilities; one general order in which a rule was adopted defining the commercial zones and terminal areas which common carriers may serve as a part of their intrastate operations in Utah; and an order in which the Commission prescribed standards and conditions under which certain motor vehicles may be exempted from stopping at specified railroad grade crossings. Authority for the action taken in the last mentioned general order is contained in Section 41-6-97, Utah Code Annotated 1953. The Commission also issued an order that cancelled 24 general orders which were obsolete and no longer served any useful purpose.

Passenger Service between Ogden, Utah and Oakland, California

On February 5, 1962, the Southern Pacific Company filed a notice with the Interstate Commerce Commission and the regulatory commissions in the states affected of its intent to discontinue passenger trains No. 27 and 28 between Ogden, Utah and Oakland, California. Hearings on the proposal were held by the ICC on April 16 in San Francisco, on April 19 in Reno, and on April 20 and May 7 in Ogden. The Utah Commission was represented and participated actively in the Ogden phase of the hearing. At the closing date of this report the ICC had not issued an order in respect to the proposed discontinuance.

Western Pacific Acquisition Cases

Reference was made in our previous annual report to the fact that Southern Pacific Company and The Atchison, Topeka and Santa Fe Railway Company each had filed an application with the Interstate Commerce Commission for authority to acquire control of The Western Pacific Railroad Company. Hearings on these applications commenced on July 12, 1961, in Salt Lake City before an ICC examiner. The Chairman of the Utah Commission appeared at the initial phase of the hearing and introduced a resolution in which the Utah Public Service Commission stated its position as favoring continued independence of The Western Pacific Railroad Company. Further hearings were held in San Francisco, Los Angeles, Seattle, and Portland with an additional hearing in Salt Lake City in October 1961. The Utah Commission was represented at and participated in the hearings at Salt Lake City and San Francisco. The hearings were finally concluded in San Francisco November 21, 1961. Briefs were filed by interested parties including an extensive brief by the Utah Commission supporting its preference for continued independence of Western Pacific. Several of the affected states and other interested groups took a similar position. The ICC examiner had not issued a proposed report in these proceedings by June 30, 1962.

Commission Finances

Total expenditures from the Commission's available funds amounted to \$150,022.94 during the fiscal year ended June 30, 1962. This figure includes \$44,333.67 which the Commission provided to meet the central administration and other costs of the Department of Business Regulation. Additional details covering the Commission's finances may be found in Table 22.

Review of Commission Orders by Supreme Court of Utah

Milne Truck Lines, Inc. v.

Public Service Commission of Utah, et al.

(Supreme Court No. 9512)

This matter came before the Court on a writ of certiorari to review an order of the Commission cancelling a tariff of Milne Truck Line, Inc., containing rates for the transportation of petroleum and petroleum products in bulk in tank vehicles. The Commission had found that Milne's authority to transport commodities generally did not include the right to transport petroleum and petroleum products in bulk in tank vehicles. Milne challenged the Commission's order on the ground that it was arbitrary, capricious, and contrary to law. The Court held that the Commission's findings that Milne Truck Line lacked authority to transport petroleum and petroleum products in bulk in tank vehicles was not arbitrary and was amply supported by the evidence. The Court affirmed the order of the Commission.

Wycoff Company, Inc., v.

Public Service Commission of Utah, et al.

(Supreme Court No. 9461)

An order of the Commission issued September 26, 1960, assessed a penalty of \$18,500 against Wycoff Company, Incorporated for repeated violations of its common motor carrier operating authority. Wycoff challenged the Commission's order in the Supreme Court, taking the position that the penalty provided for in the Public Utilities Act is criminal in nature; that it is a judicial function to determine whether the violations charged had been committed; and that accordingly the Commission had no authority to perform such a judicial function. The Court held that the Commission does possess the power to impose penalties but that a high degree of caution should be observed in determining whether there has been a violation. The Court noted that in this case there could be no question of the numerous violations of Wycoff's authority. The Commission's order was affirmed.

Joint Board Hearings

The Interstate Commerce Commission conducts numerous hearings at different points in the United States through the medium of Joint Boards, created under the Federal Motor Carrier Act. The Joint Boards hear applications of motor carriers for interstate operating authority, and make recommendations thereon to the ICC. A member of the Utah Commission or its examiner sat on a Joint Board in nine different proceedings. All of the hearings were held in Salt Lake City except one which was conducted in Phoenix, Arizona.

SECTION II

SELECTED UTILITY DATA

Trend of Electric Rates and Use of Electricity

The data presented below are included in this report to indicate the extent of the growth in use of electricity in Utah by residential customers and the declining cost thereof. The data cover the six electric utilities in Utah under the jurisdiction of the Commission. The figures show that the average cost per kilowatt-hour to the residential customer has decreased more than 50 per cent since 1935 whereas the annual average use per customer in 1961 was more than 5½ times the 1935 average consumption. The average total annual residential bill has increased 2.6 times in this same period, reflecting the higher usage. The continuous decrease in average cost per kilowatt-hour to the residential customer has been due largely to two factors, reductions in the rates of the utilities over the years and increased usage.

KILOWATT-HOUR SALES AND CUSTOMERS

Telephone Service

The Mountain States Telephone and Telegraph Company converted its Tooele exchange from common battery to No. 5 cross bar dial on August 6, 1961, at which time that office was serving 3,818 company-owned stations and 2,382 service stations. The Huntsville exchange of the same company with 375 owned stations was changed from common battery to step-by-step dial on August 20, 1961. On November 19, 1961, the Mountain States Company converted its Mt. Pleasant exchange from common battery to step-by-step dial. At the date of the change this office was serving 772 owned stations and one service station. The Nephi office with 1,336 owned stations was changed from common battery to No. 5 cross bar dial on November 19, 1961.

The following figures show the number of company-owned telephones being served as of December 31, 1961, by the 17 telephone companies operating in Utah.

The telephones at December 31, 1961, consisted of 370,041 instruments served by automatic dial equipment, 8,296 served by common battery offices, 168 radio telephones, and 16 local battery magneto telephones. Mountain States Telephone had only four offices in the state of Utah on December 31, 1961, that had not been converted to dial operation, namely, Heber City, Park City, Roosevelt, and Vernal. The Delta exchange of Millard County Telegraph and Telephone Company was also a manual common battery office at that date.

The following figures show the growth in the number of company owned telephones served by the telephone utilities operating in the state of Utah.

Natural Gas Rates and Use
