SECTION I

GENERAL SUMMARY

Introduction

During the fiscal year ended June 30, 1963, the Commission issued 250 orders in formal cases and 72 orders in other proceedings as shown by Table No. 1 in Section III of this report. These figures do not include orders of a routine nature such as those assigning hearing dates. There were 69 proceedings on file which had not been heard at June 30, 1963, and three cases that had been submitted but not decided by the Commission. The tables which form Section III of this report contain digests of the orders issued by the Commission as well as certain other information pertaining to the Commission's work.

Electric Rates and Service

The Commission issued its report and order on December 27, 1962, disposing of an application of Utah Power & Light Company for authority to publish increased rates and charges for electric service in Utah. An extensive hearing was held in this case which commenced on April 25, 1962, and was concluded August 15, 1962. There were numerous consumers and interested parties who appeared and took an active part in the hearing.

The major reason assigned by Utah Power & Light Company in support of its application for higher electric rates was a need for a change in its method of depreciation accounting. The company had been using a compound interest method of computing depreciation since 1940, with Commission approval. The Commission found from the evidence that this system of depreciation accounting was deficient and did not produce adequate annual depreciation expense charges in the light of existing economic conditions and mortgage indenture requirements of the company. The Commission authorized the company, therefore, to change its method of computing annual depreciation charges effective January 1, 1963, to a system under which the depreciation charges on existing steam and hydro production facilities shall be based on a remaining life 6 per cent compound interest method, and the depreciation charges on all other existing facilities and future plant additions, including new steam and hydro production facilities, shall be computed on a remaining life straight-line basis. There was extensive testimony introduced on behalf of the company and also on behalf of the ratepayers on the subject of a reasonable rate of return. The Commission found from the evidence that a rate of return in the area between 6.10 per cent and 6.25 per cent on an original cost rate base would be fair and reasonable. The company was authorized to file a new schedule of electric rates designed to increase its annual electric revenues in the state of Utah by not more than \$2,466,100 when applied to the volume of sales during the year ended December 31, 1961.

The increase authorized in this order is the first upward adjustment in the rates of Utah Power & Light Company since 1952. Even under the new rates the charges paid by customers of this company in Utah, particularly for residential service, are well below the national average.

Utah Power & Light Company was authorized in another order issued December 27, 1962, to acquire the property and assets of Telluride Power Company. The area which had been served by Telluride Power Company is now a part of the service area of Utah Power & Light Company and the Telluride Power Company, a corporation, has been dissolved. The system electric rates and charges of Utah Power & Light Company were made effective in the Telluride area which resulted in substantial reductions for most of the customers of the former Telluride Power Company.

Natural Gas Rates and Service

There were no changes in the rates and charges of the two natural gas distributing companies in Utah during the period of this report. The Commission disposed of one complaint against Mountain Fuel Supply Company brought by the Eimco Corporation, in which the complainant sought reparation on gas service billings for the years 1961 and 1962. The Commission in an order issued March 15, 1963, denied reparation but required Mountain Fuel Supply Company to submit new schedules which would provide for a determination of load factor in more definite terms based on estimated or actual usage, such new schedules to replace and supersede those which contained a requirement that load factor be predicated upon "potential" peak usage.

Mountain Fuel Supply Company was authorized in an order issued May 23, 1963, to extend its distribution system southward from Wanship to provide natural gas service to Peoa, Oakley, Kamas, Francis, Keetley, Heber, Midway, and contiguous areas in Summit and Wasatch Counties. Utah Gas Service Company was authorized to install the necessary facilities to serve the town of Maeser and contiguous areas in Uintah County by an order dated November 1, 1962.

The Commission dismissed six applications which had been on file for some time but not heard, for certificates of convenience and necessity to operate natural gas distribution systems in numerous cities and towns in south central and southwestern Utah. Each of these applications had been filed in anticipation of the construction of a natural gas transmission pipeline from a point near Green River, Wyoming on the pipeline of Pacific Northwest Pipeline Corporation to Provo, Utah, thence to a point on the California border. The applicants, El Paso Natural Gas Company and Colorado Interstate Gas Company, were denied a certificate of convenience and necessity by the Federal Power Commission to construct and operate such a pipeline. Had the pipeline in question been constructed there would have been a supply of natural gas adequate to serve all of the communities in Utah adjacent to the pipeline. This Commission supported the applications of El Paso Natural Gas Company and Colorado Interstate Gas Company before the FPC and took an active part in the proceedings before that Commission.

Express and Railroad Rates

There were orders issued in eight proceedings in which Railway Express Agency, Inc., was authorized to effect changes in its tariffs consisting principally of minor increases and decreases in rates. Orders were issued in six cases concerned with railroad rates. In one of these cases the Commission established higher divisions for Carbon County Railway Company on joint freight movements with The Denver and Rio Grande Western Railroad Company. Southern Pacific Company and The Western Pacific Railroad Company were authorized to increase Utah intrastate passenger fares by 10 per cent in another proceeding. Three orders involved the classification of the Western Classification Committee and one order granted reparation to a shipper in a complaint filed against Union Pacific Railroad Company.

Motor Carrier Rates

The Commission issued 23 orders in formal cases concerned with the rates, both property and passenger, of carriers by motor vehicle. Table No. 4 presents a brief digest of the action taken in each of these cases.

Grade Crossing Cases

The Commission disposed of 24 applications involving highwayrailroad grade crossings and there were 22 of such cases on file but not heard as of June 30, 1963. A summary of the orders in this category may be found in Table No. 5. In one of these proceedings the Commission designated nine grade crossings over which motor vehicles as described in Title 41-6-97(a), Utah Code Annotated 1953 as amended, may, unless a railroad train is approaching, proceed without stopping, at a speed not exceeding 25 miles per hour. Each of these nine crossings is at a location where the train movements are relatively few and the visibility from a motor vehicle on the highway is good. The orders in the other 23 cases covered such subjects as the construction of new grade crossings, the abandonment of existing ones, and other grade crossing matters. The large volume of cases of this nature in the current fiscal year, as well as in prior periods, has been due in large measure to the national highway construction program instituted several years ago.

Station Agency Cases

Changes in the shipping and traveling habits and patterns of people and business houses are gradually removing the need for railroad agency stations in many of the smaller towns and communities in Utah. During the period of this report the Commission authorized The Denver and Rio Grande Western Railroad Company to close its agency station at Gunnison; the Union Pacific Railroad Company to discontinue its agency stations at Wahsatch and Murray; and Railway Express Agency to close its agency station at Tooele. The evidence in this type of case usually shows that in recent years the volume of business handled at the station has declined to a point where it is no longer economically feasible or necessary in the public interest to continue the station on an agency basis.

Motor Carrier Authority

There were orders issued in 124 cases involving motor carrier operating authority. Digests of these orders are contained in Tables No. 8 to 14 inclusive. A general summary of such orders is as follows:

Special Permissions

There were 61 special permission orders issued to transportation companies and others in which changes in rates or other tariff provisions were authorized on less than the 30 day statutory notice. These orders are summarized briefly in Table No. 17.

Informal Dockets

There were only three orders in informal dockets, two of which authorized modifications of the Commission's General Order No. 66 relating to minimum clearances at installations served by railroads. The other order related to a reparation claim. These orders are summarized in Table No. 18.

Investigation Dockets

There were four orders issued in investigation dockets, each one of which involved a problem in the field of motor carrier transportátion. Table No. 19 contains digests of these orders.

General Orders

Supplements were issued in three outstanding general orders. In one of these the Commission's rules and regulations covering the testing of alternating current single phase meters were amended to permit use of a method known as "statistical sampling", and in another order the Sixth Edition of the National Electrical Safety Code was adopted. The third order prescribed certain amendments to the Commission's regulations governing the preservation of records of electric, gas, and water utilities. These orders are summarized in Table No. 19.

Passenger Service Between Ogden, Utah and Oakland, California

The Interstate Commerce Commission conducted hearings on an application of Southern Pacific Company to discontinue passenger trains No. 27 and 28 between Ogden, Utah and Oakland, California. The final part of the hearings was held in Ogden, Utah on May 7, 1962. An order was issued by the ICC on July 6, 1962, in which it directed Southern Pacific to continue substantially the same passen-

ger service it was then rendering between the dates of June 14 through Labor Day in September, and also between December 22 and January 2. The same order authorized Southern Pacific to discontinue passenger service on trains 27 and 28 for all other periods in the year.

Commission Finances

During the fiscal year ended June 30, 1963, total expenditures charged against appropriations available to the Commission amounted to \$164,539.37. The expenditures include \$45,513.05 provided by the Commission for central administration and other costs of the Department of Business Regulation. Table No. 20 contains further information in respect to the appropriations and expenditures.

Commission Orders Reviewed by Supreme Court of Utah

Denver and Rio Grande Western Railroad Company, Plaintiff, v. Public Service Commission of Utah and State Road Commission of Utah, Defendants

(Supreme Court No. 9727)

This proceeding developed from an order of the Commission in which it required The Denver and Rio Grande Western Railroad Company to pay 10 per cent of the cost of construction of an overpass over a spur track of this company known as the Gomex Spur in Utah County. The installation of the overpass was a part of a Federal Aid highway project. The Denver and Rio Grande Western Railroad Company challenged the Commission's order first on the ground that the Commission had no jurisdiction to apportion costs of the grade separation in this case, and second that there was no substantial evidence that the railroad would benefit by the overpass. The Court ruled against the first contention and held that even though there is an element of conjecture in respect to the benefits involved that the Commission was not unreasonable and certainly not capricious in its conclusion that the plaintiff should assume 10 per cent of the cost of construction of the overpass. The Commission's order was affirmed.

Wycoff Company, Inc. Plaintiff, v. Barton Truck Line Inc., and Public Service Commission of Utah et al., Defendants (Supreme Court No. 9717)

The Commission issued a certificate of convenience and necessity to Barton Truck Line Inc., authorizing operations as a common

motor carrier of freight from Salt Lake City to the Utah-Idaho state line and intermediate points. This service was formerly rendered by Wasatch Fast Freight, Inc., a successor to Fuller-Toponce Truck Company. The appeals of Carbon Motorway and Wycoff were denied and the Commission's order was affirmed in Cases 9716 and 9717 when the Court held that ample evidence was shown for public convenience and necessity. The plaintiffs in Case 9713, Ashworth and Salt Lake Transfer, render specialized transportation services in Utah which include the hauling of large shipments of explosives, mostly between various military bases. These plaintiffs protested the inclusion of explosives within the authority granted to Barton on the ground that public convenience and necessity did not require it because the service they offer is adequate. The Court affirmed the Commission's order pointing out that it was within the broad powers conferred upon the Commission to regulate transportation services for the benefit of the public to include in Barton's certificate the authority to handle explosives.

Wycoff Company, Inc., v. Public Service Commission of Utah (Supreme Court No. 9915)

This matter involves a complaint filed by Wycoff Company in the Third Judicial District Court of Utah in July 1961. The action was initiated following a Commission investigation into the operations of Wycoff Company which resulted in a fine being imposed against the carrier in the amount of \$18,500. The Commission's order which imposed the fine was appealed to the Utah Supreme Court and upheld.

By the action in the District Court, Wycoff Company sought to have the Motor Carrier Act (Chapter 6, Title 54, UCA 1953, as amended) declared unconstitutional and thereby avoid payment of the fine. Motions for a summary judgment by both parties were denied and the matter went to trial February 4, 1963. Substantially all of the facts were agreed upon so that the trial consisted principally of argument on the law.

After due consideration, the District Court on April 15, 1963, held in favor of Wycoff Company and declared the Motor Carrier Act unconstitutional. Further action by the Commission to collect the \$18,500 penalty was deferred pending final disposition of the constitutionality question.

The Commission filed a notice of appeal in May 1963, and the matter was awaiting argument before the Supreme Court at the close of this annual report.

Joint Board Hearings

A Utah Commissioner or the Commission's examiner sat as a member of joint boards created under the Federal Motor Carrier Act in 14 different proceedings. All of the hearings were conducted in Salt Lake City. Joint boards were established for the purpose of hearing applications of carriers by motor vehicle for operating authority. Each joint board submits its recommendation to the Interstate Commerce Commission for disposition of the application and that Commission usually follows such recommendation.

SECTION II SELECTED UTILITY DATA

Trend of Electric Rates and Use of Electricity

The information contained in the following table is presented tor the purpose of showing the increase in annual consumption of electricity by residential customers in Utah along with the decrease in cost per kilowatt-hour. It may be noted that the annual average use per residential consumer has grown from 762 kilowatt-hours in 1935 to 4,399 in 1962 while the average charge per kilowatt-hour has declined from 4.69 cents to 2.17 cents. The average annual residential bill per customer has grown from \$35.74 in 1935 to \$95.33 in 1962. This represents an increase of 2% times compared with an increase of 5% times in annual kilowatt-hour usage.

The figures in the next table show the total number of kilowatthours of electricity sold in Utah during the year 1962 and the average number of customers served by the privately owned public utilities. The total sales to ultimate consumers of 2,611,816,000 kilowatthours represent an increase of 7 per cent over the year 1961. In 1962 there was an average of 215,506 total customers served, an increase of 6,050 over 1961.

Naughton Plant of Utah Power & Light Company

The first unit of the Naughton Plant of Utah Power & Light Company, located four miles southwest of Kemmerer, Wyoming, went on the line on April 1, 1963. This unit has a rated capacity of 150,000 kilowatts and a capability of 161,500 kilowatts. Coal from a nearby deposit is used as fuel. The plant represents an investment of \$29 million including the dam and switchyard. Two more units are planned for the plant.

Telephone Service

At December 31, 1962, the 18 telephone utilities in Utah were serving 399,804 telephones. The following figures show a breakdown of the telephones in service by major classifications.

Substantially all of the telephone offices in Utah have been converted to dial operation. The 399,804 telephones in service at December 31, 1962, consisted of 395,102 dial telephones, 4,510 served by common battery offices, 176 radio telephones, and 16 magneto instruments. The Mountain States Telephone and Telegraph Company converted its exchange at Vernal, Utah from common battery to No. 5 cross bar dial on August 19, 1962, at which date this office was serving 4,424 company owned stations and 16 service stations.

The table which follows gives an indication of the annual growth which has occurred in the number of company owned telephones in Utah and also shows the total number of telephones in service at the end of each of the years included in the table.

Natural Gas Rates and Use

There are two natural gas distributing companies in the state of Utah which provide service to ultimate customers. These two companies rendered service to an average of 184,904 customers during 1962 which is an increase of 10,343 over the year 1961. The information contained in the two tables below shows the trend in annual average use of natural gas by residential and commercial customers and the cost thereof, and also total natural gas sales in the state of Utah.

In this complaint the Eimco Corporation sought reparation from Mountain Fuel Supply Company on billings for natural gas service during the years 1961 and 1962 and an order requiring Mountain Fuel to supply Eismon with natural gas service under Schedule F-1. The Commission denied reparation but required Mountain Fuel to prepare and submit new schedules which will provide for a determination of load factor in more definite terms based upon estimated or actual usage.
