SECTION I

GENERAL SUMMARY

Introduction

The Commission issued 365 orders in formal cases and 56 orders in other proceedings during the fiscal year ended June 30, 1964. Orders of a routine nature such as those assigning hearing dates or ruling on motions are not included in these figures. At June 30, 1964, there were 32 proceedings on file that had not been heard and 4 cases which had been submitted but had not been ruled upon. Table No. 1 in Section 3 of this report contains a summary of these figures. Section 3 also includes a series of tables showing digests of the Commission's orders and other information relating to the period covered by this report.

Electric Rates

* Uintah Power and Light Company submitted a new tariff in November 1963. A revised schedule covering residential service and a new rate for general commercial service result in an average reduction of approximately 11 per cent to customers under such schedules. These new schedules represent an annual saving of about \$17,000 to residential customers and \$15,000 to customers under the general service rate based upon the volume of sales in the year 1963. The new tariff became effective December 17, 1963. Uintah Power and Light Company renders electric service in Roosevelt, Duchesne, Myton, and contiguous areas.

California-Pacific Utilities Company filed a revised general service schedule with the Commission which became effective August 5, 1963. This schedule is available for a connected motor load not exceeding 300 horsepower for either single or polyphase service or a combination of both served under one meter. The revised schedule will result in an annual reduction to customers affected of approximately \$7,400 a year based on the kilowatt-hour consumption for the 12 months ended February 1963.

There were no changes in the electric rates of Utah Power & Light Company in the state of Utah.

Telephone Rates

The rate structure of The Mountain States Telephone and Telegraph Company in effect in Utah remained unchanged during the year ended June 30, 1964. The Commission authorized Moroni Telephone Company, Inc., in an order dated July 19, 1963, to make a higher level of rates effective at the time of conversion to a new telephone system in Moroni, Utah. South Central Utah Telephone Association, Inc., also was allowed to increase its telephone rates by an order issued March 13, 1964. This Association, with headquarters in Escalante, Utah, provides telephone service to numerous rural communities in Garfield, Kane, and Washington Counties.

Natural Gas Rates

Reduced rate schedules of Mountain Fuel Supply Company were approved to become effective May 1, 1964, covering residential and commercial uses, and effective July 1, 1964, applicable to industrial services. The new schedules were designed to pass on to customers the benefit of the two reductions in Federal corporate income tax rates scheduled to become effective January 1, 1964, and January 1, 1965. The new schedules will produce an annual saving to residential and commercial customers of \$182,000 and an annual saving of \$235,000 to industrial customers, or a total of \$417,000.

The rates of Utah Gas Service Company, which serves Moab, Blanding, and Vernal, and certain adjoining areas, were not altered or changed during the period of this report.

Culinary Water Rates

The Commission authorized two of the 15 water utilities operating in Utah under its jurisdiction to publish an increased schedule of rates. County Water System, Inc., which provides culinary water service in a portion of Salt Lake County, received authorization in an order issued August 8, 1963, to increase its rates in a portion of its service area. The new schedule of rates applies uniformly throughout the area served by this company. Union & Jordan Irrigation Company, which furnishes water to people in portions of the community of Union and in the vicinity of Midvale and Murray in Salt Lake County, was authorized in an order dated December 30, 1963, to effect certain increases in its schedule of rates.

Express and Railroad Rates

Several orders were issued in which Railway Express Agency, Inc., was authorized to publish changes in its Utah intrastate rates. Generally speaking the changes consisted of minor increases and decreases, the overall effect of which is not of major importance.

The Pullman Company received authorization to increase its Utah intrastate rates on exclusive use of sleeping cars. This change was in line with a similar increase which became effective on interstate traffic in the United States. The particular service involved is used very infrequently intrastate in Utah.

Local Transit Fares

The local transit industry in Utah is still faced with the problem of a continuing decline in patronage with the attending decrease in revenue and earnings. The Commission found it necessary to authorize the transit companies operating in Logan, Ogden, and Salt Lake City to increase their passenger fares. Further details may be found in Table No. 5. The Commission is fully aware of the fact that higher transit fares have a tendency to drive away some riders. Higher fares, therefore, appear to be only a temporary answer to the problems of these companies but certainly is not the final solution.

Motor Carrier Rates

There were no major changes in the intrastate rates of motor carriers operating in the state of Utah. There were several orders

issued as shown in Table No. 5 in which certain minor modifications and reclassifications were authorized in the tariffs of the motor carriers.

Grade Crossing Cases

The Commission issued orders in 42 cases relating to railroad-highway grade crossings in the state of Utah. These cases involved such matters as grade separations, crossing signals, the construction of new crossings at grade, and other matters concerned with grade crossings. The expanded activity in the area of railroad-highway grade crossings has come about to a large extent due to the national highway construction program.

Station Agency Cases

The Commission authorized Union Pacific Railroad Company to discontinue its agency stations at Modena, Wellsville, and Coalville. Railway Express Agency, Incorporated also was permitted to discontinue its agency offices in the same towns. The Denver and Rio Grande Western Railroad Company was granted permission to close its agency station at Manti. The evidence in each of these cases indicated that the revenues derived from the operation of the stations were insufficient to meet the costs of operation and that the public can be served in a satisfactory manner through other stations of the carriers.

Motor Carrier Authority

The Commission issued 201 orders dealing with operating authority of carriers by motor vehicle. Digests of these orders are presented in Tables No. 9 to 15 inclusive. The following tabulation contains a brief summary of the action taken by the Commission in these cases:

Miscellaneous Cases

A petition was filed with the Commission by certain municipal and church officials residing in the northern end of Cache County to require The Mountain States Telephone and Telegraph Company to provide extended area service between the Richmond and Logan exchanges. Under a plan of extended area service toll charges are not made on calls between points in the area. The Commission conducted a hearing on this matter on February 24, 1964, at which time the evidence submitted indicated general favorable support to the proposition. Subsequently, the Commission received petitions containing the signatures of several hundred people in the area affected in which

general opposition was voiced to the project. The Commission concluded to have a further hearing which was held in Logan on April 23, 1964. Based on the evidence submitted at this hearing the Commission concluded that a substantial majority of the people involved were opposed to the project largely because of the fact that the monthly local service charges probably would have been higher under extended area service. The Commission denied the petition.

The Mountain States Telephone and Telegraph Company filed an application with the Commission seeking the issuance to it of a certificate of public convenience and necessity embodying a description of the territory in which such company serves and holds itself out as ready, willing, and able to serve in the state of Utah. This company was incorporated in 1911 and was in operation in Utah prior to and at the time of the effective date of the Public Utilities Act of Utah which was passed in 1917. An order of the Commission dated June 1, 1964, issued a certificate of convenience and necessity to this company in which its service area in the state of Utah was delineated.

Passenger Service Between Ogden, Utah and Los Angeles, California

Union Pacific Railroad Company filed notice with the Interstate Commerce Commission on October 31, 1963, of its intent to discontinue passenger trains No. 9 and 10 operating between Ogden, Utah and Los Angeles, California, effective December 2, 1963. The Public Service Commission of Utah and other parties filed petitions with the ICC to suspend the effective date. The petitions were granted and hearings were conducted by the ICC on the proposed discontinuance. The Utah Commission participated in the hearings held in Salt Lake City and in Las Vegas, Nevada. The ICC authorized the discontinuance of trains No. 9 and 10 by an order dated March 27, 1964.

Western Pacific Acquisition Cases

Under date of September 9, 1963, Examiner Paul C. Albus issued a report and order granting the petition of The Atchison, Topeka and Santa Fe Railway Company to acquire the controlling interest in The Western Pacific Railroad Company. Exceptions were filed by the Utah Commission to the proposed report and order. At the close of the period covered by this report exceptions and replies were still being filed in this matter with the ICC.

Special Permissions

The Commission issued 45 special permissions to railroad companies, motor carriers, and others wherein authorization was given to change rates or other provisions in tariffs on less than the statutory notice of 30 days. Table No. 18 contains a summary of these orders.

Informal Dockets

Five informal dockets were disposed of, in two of which reparation awards amounting to \$188,352.58 were authorized. A digest of these orders is shown in Table No. 19.

Investigation Dockets

There were five orders issued in investigation dockets, each of which related to some phase of the operations of a motor carrier.

Investigation and Suspension Docket

The Commission disposed of only one investigation and suspension docket in which a question as to the authority of Barton Truck Line, Inc., to perform certain transportation was in issue.

A summary of the investigation dockets and the investigation and suspension docket is shown in Table No. 20.

Commission Finances

The Commission expended a total of \$146,302.32 from available appropriations during the fiscal year ended June 30, 1964. This figure includes \$26,727.04 provided from the Commission's funds for Central Administration and other expenses of the Department of Business Regulation. The last mentioned figure is considerably less than it has been for the past several years. The 1963 Legislature passed certain laws which make it possible for other divisions of the Department of Business Regulation, particularly the Registration Department, to assume a larger share of the Central Administration costs of the Department of Business Regulation. This has reduced the amount which the Public Service Commission is called upon to contribute to the Central Administration costs.

The Third Judicial Court of Utah in April 1963, declared the Utah Motor Carrier Act, Chapter 6, Title 54, U.C.A. 1953, unconstitutional. That Court held that the exemptions provided in the Act were discriminatory to motor carriers not exempt under the act and denied them the equal protection of the laws guaranteed by the Constitutions of the United States and Utah. The Commission appealed from the judgment of the District Court. The Supreme Court reversed the District Court's judgment in an opinion on February 5, 1964. The Court concluded that the classes of transportation exempted under the act are reasonable, pointing out that for the most part the transportation exempted is casual, seasonal, slow-moving, not on regular routes or schedules, frequently in special equipment, and for comparatively short distances.

Joint Board Hearings

A member of the Utah Commission or its examiner participated on eight joint boards in proceedings conducted under the Federal Motor Carrier Act. These hearings are held on applications of motor carriers for operating authority under the Federal Act. One of the hearings in which Utah participated was held at Carson City, Nevada, one at Boise, Idaho, one at Denver, Colorado, one at Helena, Montana, and four in Salt Lake City.

SECTION II

SELECTED UTILITY DATA

The Commission's previous annual reports have contained information thought to be of general interest relating to the electric, telephone, and gas utilities in Utah. The tables below update these data to include the year 1963.

Electric Rates and Use of Electricity

The following tabulation presents data covering the electric utilities in Utah on the average cost to customers of electricity and the average annual use by residential consumers. At December 31, 1963, there were only three electric utilities operating in Utah under the Commission's jurisdiction. The average cost per kilowatt-hour to residential customers increased slightly in 1963 compared with 1962 due primarily to higher rate schedules of Utah Power & Light Company which were in effect during the major part of 1963. It will be observed, nevertheless, that the annual average consumption increased in 1963 by 30 kilowatt-hours a customer.

The next table contains a summary of the number of kilowatt-hours of electricity sold in Utah along with the average number of customers served in the state during the year 1963. The total sales to ultimate consumers of 2,792,133,000 kilowatt-hours is an increase of 180,317,000 over the sales in 1962. There was an increase of 13,944 in number of customers served in 1963 compared with the year 1962.

At December 31, 1963, nearly 99 per cent of all telephones in operation were served by automatic dial offices. There were 16 magneto telephones, 4,801 common battery telephones, 187 radio telephones, and 411,279 instruments of the dial type.
