

PUBLIC SERVICE COMMISSIONERS

BRIAN T. STEWART

Ted Stewart is in his fifth year as Chairman of the Utah Public Service Commission. He was appointed a Commissioner in March of 1985. His current term of six years will end on March 1, 1991.

Stewart serves as a member of the National Association of Regulatory Utility Commissioners' (NARUC) Committee on Communications and is a member of the Western Conference of Public Service Commissioners (WCPSC).

Mecham serves as member of the National Association of RegulatoryUtility Commissioners (NARUC) and the Western Conference of Public Service Commissioners (WCPSC).



Mecham earned Bachelor and Juris Doctorate Degrees from the University of Utah.


Mecham and his wife, Angela, have one son, Nicholas, and three daughters, Charlotte, Laura, and Julia.



PUBLIC SERVICE COMMISSION OF UTAH





HISTORY OF UTAH PUBLIC SERVICE COMMISSION

The Public Utilities Commission of Utah was authorized by the Public Utilities Act which was signed by Governor Simon Bamberger on March 8, 1917. The Commission was organized on April 3, 1917, and consisted of three Commissioners, a stenographer, a reporter and a special investigator.


Legislation enacted by the 1935 Legislature changed the name of the Public Utilities Commission to the Public Service Commission, by which it is known today. In a major reorganization of Utah State Government, the first session of the 1941 Legislature created the Department of Business Regulation of Utah with a three-member Commission known as the Commission of Business Regulation. The Commission of Business Regulation also constituted the Public Service Commission.

The Utah Legislature at its regular 1969 session enacted legislation reorganizing the administrative powers in the Department of Business Regulation. The Commission of Business Regulation was replaced with an executive director of the Department of Business Regulation and the Public Service Commission was made an independent part of the Department. The Public Service Commission was prohibited from exercising any administrative authority over the Division of Public Utilities (Division), which was created to execute the rules, regulations, and orders of the Commission under the direction of the executive director of the Department. At that time, the Division audited utilities' books and records, assisted in review of legal matters, submitted recommendations to the Commission, and presented testimony and exhibits in formal cases before the Commission.

Despite the 1969 reorganization, the Division continued to function essentially as the staff of the Commission, and participated in hearings, not as an adversary party, but as a disinterested, fact-finding entity whose major role was to see that the record in the proceedings was fully developed. The Division was not precluded from making a recommendation, but its posture was perceived as sufficiently neutral that no party felt prejudiced by the Commission's full and free access to the thinking and expertise of the Division.

Since 1977, when the Division of Public Utilities first appealed a Commission decision to the Supreme Court, the Division has considered itself independent of the Commission. With legal assistance from the Attorney General's office, the Division began to participate in hearings as an adversary party, able to appeal Commission orders.

In 1977, the Legislature established the Committee of Consumer Services (Committee). The Committee is composed of five citizen members appointed by the Governor. The Committee represents the interests of residential and small commercial consumers of telephone, natural gas and electrical services. The Committee receives legal assistance from the attorney general's office and can appeal Commission decisions. It has a small staff and resides administratively within the Department of Business Regulation.



HISTORY OF UTAH PUBLIC SERVICE COMMISSION (CONT'D.)

In 1983, the Legislature reorganized utility regulation. The Public Service Commission was established as an organization independent from all other state agencies. Provision was made for a Commission technical staff, solely responsible to the Commission, and having no right of appeal. The Division of Public Utilities was statutorily established to perform the functions relative to the regulatory and adjudicative jurisdiction of the Commission that it had been doing, including appearing before the Commission as a party and appealing Commission decisions. The Division remained part of the Department. The Committee continued to function according to statute and to be part of the Department.

Currently, the Utah Public Service Commission is an independent agency having statutory duties and legislative, adjudicative, and rulemaking powers. It regulates electrical, natural gas, telephone and water utilities, and motor carrier companies.

The Commission is headed by three full-time Commissioners appointed to sixyear staggered terms by the Governor, with the consent of the senate. One member is designated by the Governor as Chairman. The Commissioners preside as a body in formal hearings concerning utility regulation matters such as applications for rate and service changes. Every public utility is subject to the jurisdiction of the Commission. A support staff of technical, legal, and clerical persons assists the Commissioners in analyzing the record in every case that comes before it, making recommendations for Commission decisions, preparing formal documents such as Commission orders, and managing the daily operation of the Commission's office.

The primary responsibility of the Commission is to ensure safe, reliable and adequate utility service. It conducts hearings and investigations of utility company operations in order to determine just and reasonable rates for service. The Commission's goal for regulation is efficient, reliable, reasonably priced utility service, which, over the long run, meets consumer demand for types and qualities of service and maintains financially healthy utility companies. This goal must, in general, be attained through the regulatory decisions the Commission makes in each formal case (docket) coming before it.

The following briefly presents, by utility type, the dockets considered by the Commission, and its formal orders issued thereon, during the period July 1989 - June 1990. No effort is made to describe the dockets or the Commission proceedings. Suffice it to say, each proceeding involves the participation of a utility and a number of other parties, including the Division and the Committee. Formal testimony of expert witnesses is taken, cross examination by each party's attorney is conducted, a transcribed record is produced, and at hearing's end, the record is closed. Thereafter, the Commission, with the assistance of its technical and legal staff, analyzes the case record, and, following deliberations, renders its decisions. This is, as a rule, a time consuming, involved, quasi-judicial process, dominated by concerns for the due process rights of parties, and by the need for a full and complete record upon which the Commission can reach decisions that, within the meaning established by law, are just and reasonable.

KEY ELECTRIC UTILITY ORDERS

JULY 1989 - JUNE 1990

Docket No. 89-035-10

In a general rate case order issued September 11, 1989, the first rate case since the Commission per-

mitted Utah Power to merge with Pacific Power in December 1988, the Commission decreased Utah & Light Company's revenue requirement by \$26,500,000.

Docket No. 88-035-08

In an order issued September 20, 1989, the Commission resolved a number of Utah Power & Light Com-

pany energy balancing account (EBA) issues. Accordingly, the EBA balance was reduced by \$2.0 million in March 1988, by \$19.5 million in November 1988, and by \$1.084 million in December 1988.

Docket No. 89-2011-01

In an order issued September 18, 1989, the Commission approved the application of Utah Associated

Municipal Power Systems (UAMPS) for a certificate of public convenience and necessity for construction of the Central - St. George 138 KV Transmission Project.

Docket No. 88-035-10

In an order issued February 9, 1990, the Commission approved a reduction in Utah Power & Light

Company jurisdictional revenue requirement of \$12,334,000, a one percent mergerrelated reduction and a refinancing reduction of \$12,642,000.

Docket No. 90-035-05

On April 4, 1990, the Commission approved a lump sum refund to Utah Power & Light Company custom-

ers of \$27,578,602 in order to satisfy, completely, Utah Power's refund payment obligations as ordered in Docket no. 84-035-12 (Simonelli case).

Docket No. 90-2035-01

In an order issued February 21, 1990, the Commission initiated the docket for the purpose of in-depth

This application is significant because the previous ten passthrough applications had resulted in decreases to Mountain Fuel Supply Company customers.

In an order issued January 25, 1990, the Commission approved rate relief for Utah Gas Service Com-

pany of \$221,000 to stem declining earnings owing to declining sales. Utah Gas Company had requested an increase of \$646,900.

(Remanded) In an order issued September 6, 1989, the Commission determined that embedded

costs, rather that long-run incremental costs, are the appropriate basis for switched access service rates. The Commission directed Mountain Bell to supply the embedded cost data in scheduled proceedings.

Docket No. 88-049-07

In a comprehensive general rate case order issued October 18, 1989, the Commission approved a

\$21,847,000 reduction in US West Communications' annual revenue requirement. The order resolved a number of test-year accounting issues; determined a cost of equity capital of 11.8 percent and a rate of return on rate base or net investment of 10.64 percent; embraced the use of embedded cost-of-service analysis for spreading revenue requirement to service or product categories; and reiterated its adherence to standard ratemaking objectives supplemented by universal service and other pricing principles.

Docket No. 89-999-01

In an order issued December 29, 1989, the Commission approved a stipulation and agreement estab-

lishing intrastate procedures for compensating telephone companies that provide intrastate telecommunications services. In connection therewith, the Commission established an expendable trust fund pursuant to sections 54-8b-11 and 54-8b-12, Utah Code Annotated.

Docket No. 89-049-19

In an order issued January 23, 1990, the Commission approved the merger of the Mountain States

Telephone & Telegraph Company, Pacific Northwest Bell Telephone Company, and Northwestern Bell Telephone Company to be effective January 1, 1991.



By order of May 10, 1990, the Commission consolidated Dockets 90-049-03, U S West Communica-

tions (USWC) application seeking approval of an incentive regulation plan, and 90-049-06, Division of Public Utilities (DPU) petition requesting the Commission to institute an investigation into the reasonableness of the rates and charges of USWC. These cases were scheduled for hearings in December, 1990.

Docket No. 90-049-06

In an order issued June 22, 1990, the Commission det e r m i n e d

that the

standards for consideration of interim rate increases and decreases need not be the same. On the basis of a prima facie showing, the Commission ordered an interim rate reduction of \$10,655,000. A 1989 test year, adjusted to be consistent with decisions made in Docket No. 88-049-07, and an 11.8 percent rate of return on equity, were used.

UTAH SPEECH AND HEARING IMPAIRED TELECOMMUNICATION PROGRAM

In 1987, the Utah Legislature enacted Senate Bill 101, the Speech/Hearing Impaired Act. Pursuant to this act, and in accordance with objectives embraced by Utah's deaf and speech-impaired community, a program has been established which creates a dual party relay system and a system to distribute special telephone devices ("TDDs") to low income individuals who are deaf or speech-impaired. The Dual Party Relay involves the intervention of an operator to relay a typed message from a deaf or speech-impaired individual to a hearing individual, or the reverse.

The Commission has adopted rules governing the operation of the program. An advisory board, consisting of representatives of the deaf, the speech impaired, government and the telephone industry, has been appointed. The board recommended criteria for selection of an operator to provide service and all parties expressing an interest in providing operators for the relay system were asked to submit proposals. On this basis, the Utah Association for the Deaf was selected to be the operator-provider, under contract.

Commission staff worked with the divisions of State Telecommunication and Purchasing to acquire, install, and test the required equipment. On January 11, 1988, the relay began to provide service 24 hours per day, seven days per week. Because program funds were limited, distribution of telephone devices for the deaf did not begin until the statute was altered to allow an increase in the surcharge levied on regular telephone subscribers' monthly bills. Since June 22, 1989, this surcharge has been seven cents. With funding

secure, the board recommended a firm to provide special telephone devices. Upon Commission approval, a contract was awarded to Ultra-Tec for this purpose. The Commission then entered into a contract with the Division of Services for the Deaf and Hard-of-Hearing to distribute the telephone devices to deaf and

speech-impaired persons, and to train them to use the equipment.

The surcharge on telephone subscriber access lines is the only source of revenue to cover the cost of providing service. There are no additional charges for using the relay for calls placed and completed within the

state. Interstate calls are allowed over the relay only if a calling card is used. This system eliminates problems of billing for interstate calls and gives the calling party the choice of a long distance carrier.

If the Utah relay meets Federal Communication Commission requirements, the state will be exempt from a mandated federal relay system. This is likely because the Utah program is successful. In fact, Utah

> has received requests from other states for assistance in setting up a similar program or asking for permission to use the Utah relay.

TRANSPORTATION

The Commission regulates motor carriers engaged in the transportation of passengers or property for hire in Utah. The regulated carrier section of the Division assists the Commission by issuing interstate carrier licenses and intrastate exempt licenses, maintaining insurance filing records, issuing cab card identification stamps, maintaining tariff filings, investigating motor carrier complaints, offering testimony at motor carrier hearings, and performing audits of regulated carriers.

The issuance or cancellation of certificates of convenience and necessity issued to common carriers, and permits issued to contract carriers, require an order of the Commission. Interstate carrier licenses require only that the carrier provide evidence of Interstate Commerce Commission (ICC) authority, evidence of insurance, and designation of process agent.
