**NOTICE OF TECHNICAL CONFERENCE**

A technical conference will be held in this docket on **Tuesday, June 21, 2016, beginning at 9:30 a.m. (MDT), Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** The purpose of the technical conference is to discuss the following issues:

- Utah Universal Service Fund (UUSF) ongoing revenue requirements.
- Regulatory options to ensure that all telecommunications providers subject to the UUSF surcharge are collecting and remitting the required revenues.
- Options to ensure ongoing funding, including the possibility of implementing a per-line/per-connection surcharge.

The Commission requests that the Utah Division of Public Utilities prepare to present the data available to the agency regarding the trend of declining UUSF revenues. Other parties in attendance will also be given a reasonable opportunity to make presentations as they see fit, but should note that the technical conference will be conducted as an open, public meeting.
