PacifiCorp hereby moves the Public Service Commission of Utah (the "Commission") for approval of the Stipulation ("Stipulation") dated August 4, 2005, a copy of which was filed with the Commission today. In support of this motion, PacifiCorp represents as follows:

1. In the above-referenced proceedings, the parties have undertaken an evaluation of the HELP program, its design and whether it is in the public interest. Since that filing, the parties have engaged in settlement discussions regarding the HELP program.

2. As a result of the settlement negotiations, the parties whose signatures appear on the signature pages of the Stipulation (collectively referred to as the "Parties") have reached a settlement regarding the HELP program and includes other terms and conditions.

3. The Parties submit that the terms of the Stipulation are just and reasonable and otherwise in the public interest.
