Re: Comcast Cable Communications v. PacifiCorp, Docket No. 03-035-28

Dear Judge Goodwill:

This letter is in response to your letter of November 9, 2004, requesting additional data regarding PacifiCorp's 2002/2003 Audit.

1. What does PacifiCorp calculate the total cost of the 2002/2003 Audit to have been? Of this amount, what are the specific amounts charged by Osmose and Volt, and what specific amount does PacifiCorp calculate its own internal Audit costs to have been?

PacifiCorp calculates the total cost of the 2002/2003 Audit to have been \$6,932,618.52 system wide. Of that amount, the specific charges were:

Osmose	\$6,245,850.55
Volt	\$ 429,967.00
PacifiCorp's internal audit costs	\$ 218,965.00

In addition, PacifiCorp has calculated the total cost of the 2002/2003 Audit specific to Utah only to have been \$3,273,284.78. Of that amount, the Utah-specific charges were:

Osmose	\$2,947,769.76
Volt	\$ 207,183.32
PacifiCorp's internal audit costs	\$ 109,974.50

2. *PacifiCorp witness Fitz Gerald testified concerning the approximate number of PacifiCorp poles in Utah. PacifiCorp witness Coppedge testified that PacifiCorp intends to spread the costs of the Audit over its entire six-state territory, but might be open to doing so on a state-by-state basis. As identified by the 2002/2003 Audit, please provide the exact number of transmission-only, distribution-only, and joint-use PacifiCorp poles for the entire PacifiCorp system and for PacifiCorp's Utah territory. In addition, provide, as identified by the 2002/2003 Audit, the total number of attachments on PacifiCorp poles across PacifiCorp's entire system as well as in its Utah territory.*

As of November 19, 2004, PacifiCorp's system-wide numbers of distribution-only, transmission-only and joint-use poles are 536,974, 19,679 and 345,318, respectively. The total number of system-wide third-party attachments was 542,161. Specific to Utah only, the numbers of distribution-only, transmission-only and joint-use poles are 189,010, 7,038 and 165,694, respectively. The total number of third-party attachments for Utah is 270,998. The numbers for Utah include the numbers generated by the 2002/2003 Audit and include adjustments to that data as recorded in PacifiCorp's Fastgate database to date.
