Pursuant to the Scheduling Order issued November 3, 2003, a scheduling conference was held in this matter on November 12, 2003. The following entered appearances:

At the Commission's suggestion, Parties met prior to the scheduling conference to discuss scheduling. At the scheduling conference, PacifiCorp reported that the parties were unable to reach agreement on a complete schedule. PacifiCorp stated that parties did agree to a technical conference on November 24, 2003 beginning at 1pm. Absent an agreed schedule, PacifiCorp proposed hearings begin the first week of January, 2004. The Division of Public Utilities (Division) concurred with a technical conference on November 24, but recommended that the remaining schedule be set after the technical conference. The Division said that the Request For Proposal (RFP) report related to this case was just received from PacifiCorp and that more time was needed to review the report to determine scheduling requirements. The Committee of Consumer Services concurred with the Division's recommendation. Mr. Dodge stated this was the first test of the stipulation dealing with least cost analysis of resource alternatives and that time for a thorough review was needed. He indicated support for the Division's proposal. Other parties also indicated support for the November 24

technical conference and setting the remaining schedule later. In light of objections from most parties to additional scheduling at this time beyond a first technical conference, the Commission will postpone setting the rest of the procedural schedule, until after the technical conference which will be held on November 24, 2003. The Commission requests that parties continue to discuss scheduling such that a schedule may be proposed at the technical conference. In the absence of agreement among the parties, the Commission will set the remaining schedule within 7 days of the technical conference.

After hearing from the parties and being fully advised, the Commission makes the following order regarding the schedule and procedure in this docket:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that:

- 1. A Technical Conference will be held on November 24, 2003 at 1pm.
