**UAE'S MOTION FOR EXTENSION OF
DEADLINE TO FILE COMMENTS ON 2004
IRP**

The Utah Association of Energy Users ("UAE") hereby moves for an extension to April 8, 2005, of the deadline for interested parties to file comments on PacifiCorp's 2004 Integrated Resource Plan ("IRP").

By Order dated February 10, 2005, the Commission requested comments on the 2004 IRP by March 24, 2005. The Division of Public Utilities has requested an extension of this deadline to at least April 1, 2005. UAE hereby requests that the deadline be extended to April 8, 2005. Both the Division of Public Utilities and the Committee of Consumer Services have indicated that they support this requested extension. Moreover, UAE has contacted PacifiCorp about the requested extension. PacifiCorp suggested that UAE file this motion, and voiced no opposition to the request.

The IRP is a long and complicated document. Moreover, as a result of Senate Bill 26,

recently enacted by the Utah Legislature and signed into law by the Governor of Utah, it is now envisioned that the Commission will “review and provide guidance” to the utility on the IRP action plan. Accordingly, UAE respectfully submits that additional time is necessary to allow it and other interested parties to file meaningful comments.
