By The Commission:

Pursuant to the Commission's June 29, 2007 Amended Notice of Scheduling Conference, a scheduling conference for the above-referenced matters was jointly held on July 11, 2007.

Rocky Mountain Power, the Division of Public Utilities, the Committee of Consumer Services, and the Utah Association of Energy Users participated in the scheduling conference regarding Rocky Mountain Power's applications for deferred accounting orders related to loans made to Grid West, the Regional Transmission Organization, MidAmerican Energy Holdings Company transition costs, and costs related to the flooding of the Powerdale hydro facility. The participants discussed scheduling issues and recommended a procedural schedule for the Commission's consideration.
