2. Regarding data requests served on or after April 21, 2006 regarding test period, parties will respond within seven (7) business days. Regarding data requests served on or after May 12, 2006 regarding test period, parties will respond within three (3) business days. Regarding data requests served on or after September 25, 2006 regarding revenue requirement and PCAM and October 6, 2006 regarding cost of service and rate design, parties will respond within eight (8) business days. Regarding data requests served on or after October 16, 2006 regarding revenue requirement and PCAM, on or after October 20, 2006 regarding cost of service and rate design, parties will respond within five (5) business days. Regarding data requests served prior to April 21, 2006 regarding test period, September 25, 2006 regarding revenue requirement and PCAM and October 6, 2006, regarding cost of service and rate design, parties will respond within 21 calendar days.

3. The parties shall, if possible, serve all filings and discovery by electronic mail. If any party does not have an electronic mail address or is unable to send documents by electronic mail, service shall, if possible, be by facsimile. If a party has neither an electronic mail address nor a facsimile number or a party is unable to serve documents by electronic mail or facsimile, documents shall be served by hand delivery or overnight courier at the discretion of the serving party. 4. Hearings shall begin at 9:00 a.m. and shall be held in the Commission's Hearing room, room 426, Fourth Floor, Heber M. Wells Building, 160 East Third South, Salt Lake City, Utah.

5. On November 23, 2005, PacifiCorp filed an application in Docket 05-035-102 seeking approval of its proposed Power Cost Adjustment Mechanism ("PCAM"). PacifiCorp filed the PCAM application in advance of its filing in this docket pursuant to the terms of a Stipulation dated November 15, 2006 entered into in Docket No. 05-035-54. The parties have determined that it is reasonable and efficient to consolidate for express purposes, this docket and Docket 05-035-102. The dockets are consolidated for the purposes of discovery, and the preparation and filing of testimony. As specified in this Order, the issues and relief requested in the two dockets are scheduled to be heard at the same time. For all other purposes, each case shall be considered a separate docket. Consolidation for the limited purposes described herein, does not require that the Commission's report and order in Docket No. 05-035-102 issue at the same time as its report and order in this docket, 06-035-21.
