The Division of Public Utilities (DPU) and the Utah Committee of Consumer Services (Committee) request a change in the filing date for Surrebuttal testimony in the test year phase of this docket from July 7, 2006 to July 14, 2006 and in support of this Motion the DPU and Committee state:

1. The Surrebuttal testimony in the test year phase of this case is currently due on July 7, 2006. The hearings are scheduled to begin July 26, 2006. When the schedule for testimony was originally established the hearing dates were earlier in July. Any rebuttal testimony is scheduled to be filed today on June 30, 2006.
2. Because of the unavailability of the DPU and Committee witnesses the week of July 3rd and other conflicts with other parties, the DPU and Committee make this request for an extension. Testimony on test year has been filed thus far by the Company, UAE, the DPU and the Committee. UAE supports this Motion and the Company has authorized the DPU and Committee to represent that this extension is acceptable.

3. Sufficient time for discovery exists between the July 14 filing date and the July 26th hearing so that no party should be prejudiced.
