1. Wasatch Wind filed an application with the Commission for approval of its proposed Power Purchase Agreement (PPA) with PacifiCorp as a Qualifying Facility under PURPA on April 12, 2006.

As such we have a direct interest in these proceedings and the outcome may have a direct impact to investing in projects in Utah.
