Rocky Mountain Power (“Rocky Mountain” or “Company”) hereby moves the Public Service Commission of Utah (the “Commission”) to enter a protective order in the form attached hereto as Exhibit A. Rocky Mountain requests that the Commission issue this protective order on an expedited basis. The grounds for this motion are as follows:

1. The Company has received written data requests regarding its filing in the above-referenced matter and the entry of the proposed protective order on an expedited basis will expedite and facilitate the exchange of information by the parties by affording protection to valuable, confidential, trade secret, and proprietary business information.
2. The proposed protective order is fair and equitable to all parties and provides the parties and the Commission with access to information while allowing for the protection of the integrity of confidential information.

3. The proposed protective order is in substantially the same form as protective orders entered by the Commission in recent cases involving this and other utilities under its jurisdiction, including the protective order entered in Rocky Mountain's last general rate case.

WHEREFORE, Rocky Mountain respectfully requests that the Commission enter the protective order in the form attached hereto on an expedited basis.
