Gregory N. Duvall is Director of Long Range Planning and Net Power Costs. As director, he has responsibility for the integrated resource planning group, the load forecasting group, and the market assessment group in PacifiCorp Energy, a division of PacifiCorp, and coordinating and preparing the net power cost and related analyses used in retail price filings with the company's six state regulatory commissions.

Duvall joined Pacific Power in 1976 and has held various positions in resource and transmission planning, regulation, resource acquisitions and trading. From 1997 through 2000 Mr. Duvall lived in Australia where he managed the Energy Trading Department for Powercor, a PacifiCorp subsidiary at that time. After returning to Portland, he was involved in direct access issues in Oregon, and was responsible for directing the analytical effort for the Multi-State Process ("MSP").

Duvall has a bachelor's degree in Mathematics from the University of Washington in 1976 and a Masters of Business Administration from the University of Portland in 1979.
