By The Commission:

On January 3, 2008, PacifiCorp, doing business in Utah as Rocky Mountain Power ("Company"), filed with the Utah Public Service Commission ("Commission"), a request to eliminate the requirement to file the Utah Annual Report, which is the Utah State version of the Federal Energy Regulatory Commission ("FERC") Form 1 report. In the alternative, the Company requests an extension of the filing requirement date.

On April 18th of each year, the Company is required by the FERC to file a FERC Form No. 1 detailing the total utility financial and operating results for the preceding calendar year. At the same time each year the Company also files the Utah Annual Report with the Commission, which contains the results allocated to the Utah jurisdiction obtained from the FERC Form 1 total Company report. In addition, the Company is also required to file a "Semi-Annual Report." The Semi-Annual Report for the total Company includes detailed calculations of the all Company's revenues and costs and subsequent allocation to jurisdictions, including its Utah jurisdiction. The Semi-Annual Report is filed with the Commission twice a year. A report is filed no later than April 30 containing the results for the 12-months ending December of the

prior year. A report is also filed in October containing the results for the 12 months ending June of the current year.

The Company requests it no longer be required to prepare and file the Utah State version of the FERC Form 1 report. If the Commission determines that filing the Utah version of the FERC Form 1 report is still required, the Company requests the Commission grant the Company a permanent extension of the filing deadline for this annual report to May 31 each year, one month after the calendar year Semi-Annual Report is filed. This will allow the jurisdictional results of operations, which serves as the basis for the state allocations, to be finalized and filed subsequent to the preparation and filing of the Utah Annual Report.

The Division states the FERC Form 1 report and Semi-Annual Report provide alternative reports to the Utah Annual Report to assist it in its statutory duties and therefore the Utah Annual Report is redundant and unnecessary. Therefore, the Division recommends the Commission eliminate this filing requirement.

We conclude the portion of the Utah Annual Report relating to Utah-allocated financial results is unnecessary due to the filing of the FERC Form 1 and the filing of the Semi-Annual Reports and grant the Company's request to eliminate this part of the filing. However, we find value in the portion of the Utah Annual Report relating to the summary of Utah-specific electric operating revenues, Account 440. We direct the Company to continue filing this information in the same content and format. Since this part of the Utah Annual Report does not require allocations of utility system cost to Utah, we understand no filing date extension is necessary.

- 2. The portion of the Utah Annual Report relating to electric operating revenues shall continue to be filed with the existing content, format and filing date.
