Subject: Garkane Energy's Revised New Rate Schedules Docket No. 09-028-T01

ISSUE:

Garkane Energy Cooperative, Inc., (Garkane) filed with the Utah Public Service Commission, (PSC) new Rate Schedules.

RECOMMENDATION:

The Division recommends that the PSC acknowledge Garkane's new rate schedules, with an effective date of July 1, 2009, and make them available for public inspection.

DISCUSSION:

Garkane filed new rate schedules with an effective date of July 1, 2009. The new rate schedules reflect rate increases for all schedules and include the rates for the recently acquired distribution assets of Hildale, Utah, which Garkane now serves, after receiving the approval of the PSC.¹

With the acquisition of the Hildale, Utah distribution assets, Garkane now has separate residential service schedules for Kanab, Hildale and for residential service outside of these two areas.
