- 2. The Commission has scheduled a hearing on Rocky Mountain's application in Docket No. 09-035-59 for November 4, 2009, 9:30 a.m. to 10:30 a.m.

3. On September 3, 2009, Rocky Mountain filed its application for approval of a

Power Purchase Agreement ("PPA") with Kennecott, which was entered as Docket No. 09-035-

62.

4. Docket Nos. 09-035-59 and 09-035-62 both concern the approval of contracts

between Rocky Mountain and Kennecott.

5. Docket No. 09-035-59 concerns the approval of a contract for Rocky Mountain to

provide back-up and supplemental electric service to Kennecott, and Docket No. 09-035-62

concerns the approval of a contract for Rocky Mountain to purchase electric energy from

Kennecott's qualifying facility ("QF").

6. Rocky Mountain and Kennecott are both the only parties to both contracts, and

the witnesses and representatives for Kennecott will be the same in both instances.

7. Upon conferring, counsel for Rocky Mountain indicated to counsel for Kennecott

that Rocky Mountain has no objection to scheduling the hearings sequentially.

CONCLUSION

Based on the foregoing, Kennecott requests that the Commission issue a Scheduling

Order setting the hearing for Docket No. 09-035-62 so that it will be heard directly following the

hearing scheduled for Docket No. 09-035-59 on November 4, 2009, 9:30 a.m.
