Tariff Rider Rate

This filing is submitted in compliance with the Requested Commission Order on the Stipulation in the Cost of Service and Rate Spread Phase in Docket No. 08-035-38 (Stipulation) implementing a \$45.0 million increase in annual revenue requirement. The proposed Schedule 98 will replace the compliance tariff sheet Schedule 98 filed by the Company April 24, 2009. Proposed Schedule 98 identifies a different percentage increase to each rate schedule as set forth in Exhibit A (Column 11) of the Stipulation and will be applied to all tariff customers' bills as a line item for service. The percent increase for each schedule shown on proposed Schedule 98 is the result of the stipulated spread of the \$45.0 million increase applied to current rates including the current 2.96 percent Schedule 97 rider.

This filing supplements the April 24, 2009 compliance filing (Advice No. 09-06) filed in this docket. The Company requests that the proposed tariff Schedule 98 submitted with this current filing replace the Schedule 98 tariff sheet submitted in Advice No. 09-06. Concerning the other tariff sheets submitted in Advice No. 09-06, as agreed to by the parties to the Stipulation, Rocky Mountain Power requests that the Commission approve the revisions to Schedule 193, the cancellation of Schedule 97, and the revisions to the Index Sheet No. B.1A submitted in that filing.
