PacifiCorp represents the change will allow it to provide actual data for the first five months of a program year, which will provide the Commission and the DSM Steering Committee a more accurate look at projected expenditures while sufficient time remains in the year to collaborate with respect to potential changes. PacifiCorp represents it has discussed the proposed new due date with the Office of Consumer Services and the Division of Public Utilities and that neither opposes the Request and agrees it will bring added value to the Semi-Annual Report.
