Regulation 12 – Line Extension Policy, Housekeeping Filing

The purpose of this filing is to consolidate tariff language to Electric Service Regulation No. 12 that was approved previously in two separate dockets, Docket 08-35-T05 and Docket 07-035-93.

On July 15, 2008, Rocky Mountain Power filed proposed changes to Electric Service Regulations No. 12. Comments are recommendations for modifications to these changes were proposed by both the Division of Public Utilities and the Committee of Consumer Services. On September 23, 2008, Rocky Mountain Power made a supplemental filing reflecting the recommendations of the Division and Committee. This filing was approved by the Commission on October 28, 2008, with an effective date of September 30, 2008.

Additional changes to Regulation 12 were proposed in the 2007 general rate case, Docket 07-035-93. In Rocky Mountain Power's October 10, 2008, filing in compliance with the Commission's Phase II Order on the Stipulation in Cost of Service, Rate Spread and Rate Design in Docket No. 07-035-93, the additional changes to Regulation 12 were included.

Because of differing versions of paragraphs 3(d) and 3(e) on sheet 12R.8, and overlapping approval dates, the language in the currently approved version of the tariff is incomplete. The currently approved sheet 12R.8 includes the correct language for Paragraph 3(d) but excludes paragraph 3(e). This filing adds paragraph 3(e).

Enclosed for filing are an original and two copies of proposed tariff sheets associated with Tariff P.S.C.U No. 47 of PacifiCorp, d.b.a Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, Rocky Mountain Power (the "Company") states that the proposed tariff sheets do not constitute a violation of state law or Commission rule. The Company will also provide an electronic version of this filing to tbehr@utah.gov The Company is requesting an effective date of August 31, 2009 for these changes.
