On August 27, 2009, the Commission issued its order in the above referenced docket, approving the Company’s proposed flexible tariff modification process for the Home Energy Savings program (Schedule 111). The Commission also directed the Company to file revised Schedule 111 tariff sheets reflecting certain decisions made by the Commission in the order. Rocky Mountain Power has revised the attached Schedule 111 tariff sheets to reflect the following decisions made by the Commission.

- a) The Commission indicated the flexible tariff modification process for Schedule 111 originally proposed by the Company in this docket<sup>1</sup> does not allow for an adequate regulatory review and final action by the Commission. The Company was directed by the Commission to modify the Schedule 111 tariff sheets to incorporate these regulatory steps into the tariff modification process for the Home Energy Savings program. Mountain Power has modified the attached Schedule 111 tariff sheets to address these concerns. Going forward, as directed by the Commission, for the Home Energy Savings program tariff Rocky Mountain Power will submit a full tariff change filing<sup>2</sup> to the Commission at the beginning of the 45-day review period and will not implement proposed changes until receiving explicit approval from the Commission through an order.

- b) The Commission stated it must have full and complete information in its own records regarding the Company's tariffed programs to fulfill public information requirements. Such information includes the details of program administrative practices and incentive levels. In its original filing in this docket, the Company removed Table 1 from Schedule 111, which contains the Home Energy Savings program's qualifying equipment or services and incentives. In compliance with the Commission's direction, Rocky Mountain Power has returned Table 1, reflecting currently approved program incentives, to the attached Schedule 111 tariff sheets.

Rocky Mountain Power believes the attached Schedule 111 tariff sheets reflect the Commission's intent in their order in this proceeding.
