Rocky Mountain Power, a division of PacifiCorp, ("Rocky Mountain Power" or "Company"), hereby moves the Public Service Commission of Utah ("Commission") to vacate the revenue requirement hearing dates of July 27, 2011 – August 2, 2011 and hold a hearing on August 3, 2011 (1) for approval of a revenue requirement stipulation which Rocky Mountain Power, the Utah Division of Public Utilities (the "Division"), the Utah Office of Consumer Services (the "Office"), the Utah Industrial Energy Consumers ("UIEC"), and UAE Intervention Group ("UAE"), among other parties, intend to enter into, and (2) to consider any and all opposition to the Stipulation. In support of this Motion, Rocky Mountain Power states as follows:

- 1. On January 24, 2011, Rocky Mountain Power filed an application, together with supporting testimony and exhibits, requesting approval of an increase in its retail electric utility service rates in Utah in the amount of \$232.4 million.
- 2. On February 23, 2011, the Commission issued an order establishing the procedural schedule for this case. Hearings in this docket are scheduled to begin on July 27, 2011 on revenue requirement issues.
- 3. On July 21, 2011, notice was provided to all intervenors advising all parties who filed revenue requirement testimony and others that certain parties had reached an agreement in principle, and that a draft stipulation would be circulated.
- 4. A draft stipulation was circulated to all intervenors July 22, 2011. Parties reviewed the stipulation as a group on July 26, 2011, and will continue to review the stipulation as a group on July 27, 2011.
- 5. Parties expect that the settlement stipulation on revenue requirement will be finalized and filed with the Public Service Commission of Utah July 28, 2011.
- 6. Consequently, the Company respectfully requests that the Commission vacate the hearing dates July 27, 2011 through August 2, 2011 and hold the hearing for consideration and approval of the settlement stipulation commencing on Wednesday, August 3, 2011 at 8:00 a.m. (MDT), in accordance with the following procedure: (a) Rocky Mountain Power, the Division, and the Office each shall, and other parties to the stipulation may, make one or more witnesses available to explain and offer further support for the stipulation; (b) any party opposing the stipulation will have an opportunity to cross examine the witnesses supporting the stipulation and to present its witnesses providing the basis for

its opposition to the stipulation, and (c) other parties will have the

opportunity to cross examine opposing witnesses and present rebuttal

witnesses.

7. This Motion is not intended to modify the time and place requested for the

hearing in the Stipulation on Cost of Service, Rate Spread and Rate Design or the

Division's Motion to Modify Schedule to Hold Public Witness Testimony Day

Hearing on August 8, 2011.

WHEREFORE, Rocky Mountain Power respectfully requests that the

Commission vacate the revenue requirement hearing dates July 27, 2011 through

August 2, 2011, hold the hearing for consideration and approval of the Stipulation

on Wednesday, August 3, 2011 at 8:00 a.m. (MDT), and consider any opposition

to the stipulation on August 3 and 4, 2011, pursuant to the procedure set forth
