Management Plans from the Plan of Development

<u>Traffic and Transportation Management Plan</u>: This component of the POD addresses measures to be undertaken to assure that impacts on roads, traffic and users of roads are minimized. The plan also contains fugitive dust suppression measures. Rocky Mountain Road Construction Standards are included in Attachment 12.

Reclamation, Revegetation, and Weed Management Plan: This component of the POD addresses measures to be undertaken to assure reclamation and revegetation and prevent accidental introduction or transport of noxious weeds along the right-of-way during, after construction, and after ground-disturbing activities. The Reclamation, Revegetation, and Weed Management Plan will include site-specific restoration measures, species to be replanted, and monitoring. It combines Rocky Mountain Power's Best Management Practices with site-specific mitigation developed in consultation with the agencies. A copy of the Draft Reclamation, Revegetation, and Weed Management Plan is included in Attachment 13.

<u>Stormwater Pollution Prevention Plan</u>: These are the measures to be undertaken to prevent stormwater pollution; to comply with criteria in Environmental Protection Agency's (EPA's) Clean Water Act, and to comply with any State and local regulations regarding stormwater management including drainage.

<u>Spill Prevention, Containment and Countermeasures Plan</u>: This component of the POD contains set practices and requirements that contractors shall follow to prevent the release of fuels, lubricants and solvents. The plan includes spill cleanup and incident reporting procedures as well as instructions for refueling and operating equipment near waterbodies.

<u>Cultural Resources Plan</u>: This component of the POD outlines the procedures to be undertaken to inventory, evaluate, and protect cultural and paleontological resources. In addition to preparing a Cultural Resource and Paleontological Monitoring and Mitigation Plan, Rocky Mountain Power will prepare and submit a Treatment Plan for any historic property eligible for or listed on the National Register of Historic Places (NRHP) that will be impacted by the Project. The plan will specify how each property or site will be treated, including mitigation measures. The Plan will include an Unanticipated Discovery Plan that details the steps to be taken during construction in response to a new find of an historic property or site potentially eligible for listing on the NRHP during construction.

<u>Plant and Wildlife Conservation Measures</u>: Rocky Mountain Power will prepare a site-specific Plant and Wildlife Conservation Measures Plan as a component of the POD. This plan will include measures to be implemented in the event federally listed species, BLM sensitive species, or State of Utah special status species or their habitats occur within or adjacent to the right-of-way of the Project. This plan will identify general and site-specific BMPs practices for those plant and animal species for which potential habitat exists. In addition, the plan will provide specific mitigation measures for federally protected species and designated special status species.
