APPLICATION OF ROCKY MOUNTAIN POWER

PacifiCorp, doing business in Utah as Rocky Mountain Power ("Rocky Mountain Power" or "Company") respectfully requests an order under Utah Admin. Code R746-345-3 approving a standard form Pole Attachment Agreement (the "Agreement") to be utilized between Rocky Mountain Power and cable and/or telecommunications companies desiring to attach facilities to the Company's distribution poles. In support of its Application, Rocky Mountain Power states as follows:

1. Rocky Mountain Power is a public utility in the state of Utah and is subject to the jurisdiction of the Commission with regard to its rates and service. As a public utility that permits attachments to its poles by an attaching entity, Rocky Mountain Power is obligated to provide that service pursuant to the requirements in Utah Admin. Rules, R.746-345 governing pole attachments.

2. Under R.746-345-3, Rocky Mountain Power is obligated to submit to the Commission for approval a standard contract specifying the rates, terms and conditions for pole attachments.

4. The proposed Agreement is substantially similar to the pole attachment agreements with TCG Utah and Leavitt Group Enterprises, approved by the Commission in Docket Nos. 09-035-52 and 10-035-01, respectively.

5. Differences between those previously-approved agreements and the proposed Agreement include various clarifications of responsibilities, additional definitions, and updates reflecting the Company's changed business requirements. Where UAR 746-345-3(C) requires a certain timeline for Make–Ready work, the Agreement has been modified to state that the process shall conform to the requirements of UAR R746-345-3 rather than

stating specific timelines. Pole replacement costs have been consolidated under the Make-Ready requirements in Section 3. Section 6 has been updated with the Company's most recent security, credit and insurance requirements. Further, the Agreement includes new provisions allowing for the installation of wireless facilities on the Company's distribution poles. The Agreement reflects the non-reciprocal relationship between the parties.

6. Differences between the TCG Utah pole attachment agreement and the Commission's "Safe Harbor" agreement were described in the Company's application in Docket No. 09-035-52 and in the Division of Public Utilities' July 29, 2009 Memorandum to the Commission in that docket, which descriptions are incorporated herein by reference.

7. The Agreement provides for pole attachment rates consistent with the Company's Electric Service Schedule No. 4 and Commission Rule R746-345, requires compliance with National Electric Safety code requirements, and is otherwise consistent with the requirements of Commission Rule R746-345.

8. The Agreement is just and reasonable and in the public interest.

WHEREFORE, Rocky Mountain Power respectfully request that the Commission issue an order approving the Agreement submitted herewith and finding the terms and conditions of the Agreement to be just and reasonable and in the public interest.
