Based upon discussions at the duly noticed Scheduling Conference held August 26, 2010, in this matter, the Commission issues the following Scheduling Order, which shall govern in this docket unless otherwise ordered by the Commission:

Thursday, September 9, 2010	Deadline for Responses to the UIEC Motion to Defer Recovery of the Major Plant Addition Costs.
Thursday, September 16, 2010	Deadline for Replies to the UIEC Motion to Defer Recovery of the Major Plant Addition Costs.
Tuesday, September 28, 2010	The Commission, may hold a hearing on UIEC Motion to Defer Recovery of the Major Plant Addition Costs. If held it will be at 3:00 p.m. in Room 403 , Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.
Tuesday, October 26, 2010	Deadline for interested parties to intervene.
Tuesday, October 26, 2010	Deadline for parties besides Rocky Mountain Power to file Direct Testimony.
Thursday, November 18, 2010	Deadline for parties to file Rebuttal Testimony to Direct Testimony filed October 26, 2010.

- Tuesday, November 23, 2010 Settlement Notification Deadline. If notice is not provided to the Commission on or before this date that a comprehensive settlement or revenue requirement settlement has been reached by substantially all parties, then the alternative COS Hearing date of December 13, 2010, shall become firm.
- Tuesday, November 30, 2010 Deadline for parties to file Sur-rebuttal Testimony to Rebuttal Testimony filed November 18, 2010, or any settlement proposal.
- Monday, December 6, 2010 **Hearing** Date, beginning at **9:00 a.m.**, **Room 403**, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The purpose of this hearing will be to hear testimony and evidence on (i) any settlement agreement , or (ii) revenue requirement issues, absent a settlement; or (iii) cost of service and rate design issues, in the event of a revenue requirement settlement.
- Monday, December 6, 2010 **Public Witness** testimony will be taken from **11:30 a.m. – 12:30 p.m.** in **Room 403**, Heber M. Wells Building, Salt Lake City, Utah
- Monday, December 13, 2010 In the absence of a settlement, **Alternate Hearing** Date, beginning at **9:00 a.m.**, **Room 403**, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The purpose of this hearing will be for cost of service and rate design issues, in the absence of a settlement.
1. Discovery turn-around times.
 - a. On or before October 25, 2010, within 14 calendar days.

- b. Between October 26, 2010, and November 17, 2010, within 7 calendar days.
 - c. On or after November 18, 2010, within 5 calendar days.
2. Parties shall serve copies of all filings on other parties by electronic mail at or before the time an electronic copy of the document is filed with the Commission. Parties shall serve discovery requests and responses on applicable parties by electronic mail. In the event a document filed with the Commission or produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party filing the document shall file an electronic copy of the document on CD with the Commission by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on applicable parties by hand delivery if the party being served is in the same metropolitan area as the serving party or by overnight courier if the party being served is located in a different metropolitan area from the serving party.
 3. The Public Witness Hearings in the foregoing schedule shall begin at the time indicated and conclude when individuals present have finished their testimony or comments. The Commission may limit presentations of testimony or comments that are unduly repetitious. Any individual wishing to present a statement of position to the Commission that is

unable to do so during the Public Witness Hearing may file a written statement of position with the Commission at its offices, Fourth Floor, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah 84111 in person, by mail, by electronic mail to psc@utah.gov, or by facsimile to (801) 530-6796.

4. Utah Code Section 54-7-13.4(4)(a)(iii)(B) requires the Commission to issue an order on cost recovery by December 31, 2010, which is 150 days from the complete filing date. If the Alternate Hearing Date of December 13 is required to complete hearings in this docket, the Commission will, on December 6, entertain recommendations from the parties concerning compliance with this section.
5. If Rocky Mountain Power files a general rate case prior to issuance of the Commission's Order in this docket, the Company's filing shall not be considered incomplete or subject to suspension of the 240-day requirement of Utah Code Section 54-7-12(3)(a) because its filing and requested rate increase do not incorporate the results of the Order in this docket, provided that within 14 days of the Order the Company files new schedules necessary to incorporate all appropriate impacts of the Order. Nothing in this Order shall prevent a party from challenging completeness or seeking suspension of a company filing for any other reasons.
