Service

Recommendation (Conditional Approval)

The Division recommends that the Commission approve the proposed tariff pages as complying with the Commission Order in Docket No. 08-035-78 and Administrative Rule R746-312 with the following modification. The reference for the exceptions for the disconnect switch in Special Condition 6 in Sheet 135.5 should be changed from R746-312-2 to R746-312-4-2a.

Issue

On May 26, 2010, Rocky Mountain Power (RMP or Company) filed its proposed tariff pages for Schedule 135 and accompanying Exhibit 1, which shows the calculation of average retail rate credits for large non-residential customers. On June 1, 2010, the Commission issued an Action Request to the Division requiring a response by June 24, 2010. On June 23, 2010, the Division filed its response to this Action Request recommending approval. On June 24, 2010,



the Commission issued an additional Action Request requesting further comments. This

memorandum is the Division's response to the Commission's June 24, 2010 Action Request.

In its June 24, 2010 Action Request, the Commission asked the Division to provide

further comment on (1) whether the Division thinks that the Company's proposed 30 days

notification period in Special Condition 4 on Sheet 135.4 is reasonable, (2) whether R746-312-2

reference in Special Condition 6 on Sheet 135.5 is correct and (3) whether the proposed wording

in Special Condition 6 should be enhanced to specify that exemptions to the disconnect switch

location exist.

Discussion

The 30 days notification period indicated in Special Condition 4 is consistent with the

language in R746-312-15-2. Therefore, the Division believes that no further comment is needed

on this issue. However, the Division notes that the R746-312-2 reference in Special Condition 6

on Sheet 135.5, dealing with exceptions to the requirements for the disconnect switch, is

incorrect. The correct reference for the exceptions, including the location exemption, should be

R746-312-4-2a. The Division recommends that the Commission direct the Company to correct

this reference and re-file its tariff. Given the correction to the reference, the Division does not

believe that the proposed wording in Special Condition 6 needs to be enhanced to specify that

exemptions to the disconnect switch location exist. With the correct reference, interested

customers should be able to locate the applicable exceptions.

Therefore, the Division recommends that the Commission approve the proposed tariff

pages as complying with the Commission Order in Docket No. 08-035-78 and Administrative

Rule R746-312 with the modification indicated above.
