Schedule 37 – Avoided Cost Purchases from Qualifying Facilities (QF)

On June 7, 2010, Rocky Mountain Power filed to "update the avoided cost pricing in Schedule No. 37. On June 29, 2010, the Division of Public Utilities filed comments recommending that "the Commission direct the Company to either redo the avoided cost calculations or verify that the discount rate and the payment factors used in the filing are correct." On July 1, 2010, the Company discussed the DPU recommendations with the Commission staff and was encouraged to supplement the filing and address those recommendations. This filing addresses recommendations of both the Commission staff and the DPU.

As recommended, the attached tariff sheets and supporting work papers have been revised to reflect different payment factors for the combined cycle (8.26%) and the simple cycle (8.31%) combustion turbines. The 7.17% discount rate employed in the calculations is the Company's official March 2010 discount rate and has not been changed from the June 7, 2010 filing. Rocky Mountain Power has verified that both the discount and the payment factors are consistent with those used in the 2008 IRP Update filed March 31, 2010.

Enclosed for filing are an original and two copies of proposed tariff sheets associated with Tariff P.S.C.U No. 47 of PacifiCorp, d.b.a Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, PacifiCorp states that the proposed tariff sheets do not constitute a violation of state law or Commission rule.
