ISSUED: January 31, 2011

By The Commission:

1. On January 24, 2011, PacifiCorp, d/b/a Rocky Mountain Power ("PacifiCorp" or "Company") filed an Application for Approval of the Electric Service Agreement between Rocky Mountain Power and Milford Wind Corridor Phase II, LLC ("Milford II").

2. On January 24, 2011, Milford II filed with the Commission a Motion for an Interim Order Authorizing Rocky Mountain Power to Provide Electric Service ("Motion for an Interim Order"), pending the issuance of a final order on the Company's Application for Approval of the Electric Service Agreement ("Application").

3. Pursuant to a Notice of Expedited Hearing issued on January 25, 2011, hearing on Milford II's Motion for an Interim Order was held on January 27, 2011. Rocky Mountain Power, Milford II and the Division of Public Utilities appeared at hearing. No party had any objection to the issuance of an interim order approving the Electric Service Agreement, and all of the parties present proffered statements that such an interim order would be in the public interest.

4. The Office of Consumer Services ("OCS") did not appear at the hearing, but filed on January 26, 2011, OCS' Appearance, Request for Notice and Response to Milford II's Motion for an Interim Order. The OCS concluded that granting Milford II the relief requested would be in the public interest, conditioned upon the Commission considering the merits of Rocky

Mountain Power's Application in regular proceedings to be scheduled and conducted in accordance with the Commission's procedures and practices.

5. Having considered the pleadings and papers on file, and the statements of the parties at hearing, the Commission finds that granting Milford II's Motion for an Interim Order is in the public interest.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. The Electric Service Agreement between Rocky Mountain Power and Milford II is hereby approved on an interim basis, effective as of January 27, 2011, pending the Commission's final order on Rocky Mountain Power's Application.

2. Regular proceedings will be scheduled and conducted in accordance with regular Commission procedures and practices.
