Pursuant to Utah Code Ann. § 63-46b-9 (1992) and Utah Admin. Code § R746-100-7, Mrs. Corinne Nielson Roring, Trustee hereby moves for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Mrs. Roring states as follows: Pursuant to Utah Code Ann. § 54-12-2,

1. I am the Trustee for the John Edward Roring and Corinne Nielson Roring Revocable Living Trust (the "Trust"), dated December 28, 1992.

2. PacifiCorp, doing business in Utah as Rocky Mountain Power ("Rocky Mountain Power" or "Company") filed an application with the Commission for an order approving the Power Purchase Agreement ("Agreement") between PacifiCorp and Blue Mountain Wind 1, LLC ("Blue Mountain Wind") dated November 8, 2011.

3. The Trust is the Lessor of the largest portion of land in the Blue Mountain Wind 1, LLC project.
4. The Agreement relies on wind data taken from a meteorological tower located on the Trust's land.
5. The outcome of this proceeding will directly impact the Trust, my family, and my land.
6. I have not yet identified the precise position I will take in this matter; however the Trust's interests will not be adequately represented by any other party.
7. The Trustee's participation will not delay or impair the conduct of the proceeding.


