The Applicant shall file narrative and numerical joint comparison exhibits on or before **August 15, 2012,** addressing parties' positions on revenue requirement issues as presented in pre-filed testimony (direct through sur-rebuttal). Similarly, the Applicant shall file narrative and numerical joint comparison exhibits on or before **August 22, 2012,** addressing parties' positions on cost of service and rate design issues as presented in pre-filed testimony (direct through sur-rebuttal). These comparison exhibits shall present a brief summary of the position of each party on contested issues. A matrix format may be best suited for this purpose. The parties shall cooperate in the preparation of the comparison exhibits so they fairly express each party's position as reflected on the record.

Parties shall file testimony with the Commission in accordance with the foregoing schedule and shall follow the procedures set forth at "PSC Filing Requirements" under the "MISC" tab on the Utah Public Service Commission website homepage. Additionally, written testimony and other exhibits offered into evidence shall conform to Utah Administrative Code R746-100-10(F)(2). In particular, they shall adequately explain: "Explicit and detailed sources of the information contained in the exhibit; methods used in statistical compilations, including explanations and justifications; assumptions, estimates and judgments, together with the bases, justifications and results; formulas or algorithms used for calculations, together with explanations of inputs or variables used in the calculations." Parties shall serve copies of all filings on other parties by electronic mail <u>at or before</u> the time an electronic copy of the document is required to be filed with the Commission.

The Applicant has informed the Commission and various parties that it intends to file an update of its net power cost testimony and exhibits on May 11, 2012. This update will include the supporting work papers. The Applicant has stated it will use its best efforts also to update at that time any of its prior data request responses affected by the updated information. Additionally, the Applicant has stated it will not object to parties using both their direct and rebuttal testimony to respond to the updated information.

DISCOVERY

Responses to discovery requests served within the following phases and time frames shall be provided within the designated number of days:

Cost of Capital Phase:

Until May 31, 2012, within 21 calendar days. Until June 27, 2012, within 14 calendar days. After June 27, 2012, within 5 calendar days.

Revenue Requirement Phase:

Until June 11, 2012, within 21 calendar days. Until July 13, 2012, within 14 calendar days. After July 13, 2012, within 5 calendar days.

Cost of Service and Rate Design Phase:

Until June 22, 2012, within 21 calendar days. Until July 27, 2012, within 14 calendar days. After July 27, 2012, within 5 calendar days.

The foregoing response intervals are similar to those employed in the Applicant's last general rate case and should guide parties' responses to any data requests pending at the time of this order.

Parties shall serve discovery requests and responses on applicable parties by electronic mail. In the event a document filed with the Commission or produced in response to a

discovery request cannot reasonably be transmitted by electronic mail, the party filing the document shall file an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) with the Commission by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on each applicable party by hand delivery if the party being served is in the same metropolitan area as the serving party, or by overnight courier if the party being served is located in a different metropolitan area from the serving party.

PUBLIC PARTICIPATION

The Public Witness Day hearing in the foregoing schedule shall begin at the time indicated and end when individuals present at the beginning have finished their comments. The Commission may limit presentations of testimony or comments that are unduly repetitious. Any individual wishing to present a statement of position to the Commission that is unable to do so during the Public Witness Day hearing may file a written statement of position with the Commission at its offices, Fourth Floor, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah 84111 in person, by mail, by electronic mail to tbehr@utah.gov, or by facsimile to (801) 530-6796. Please indicate that the statement pertains to Docket No. 11-035-200.

Participants attending by telephone should then call the Public Service Commission, using one of these same telephone numbers, five minutes prior to the hearing to ensure participation.
