Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Petitioners Utah Association of Energy Users, ATK Propulsion Systems, American Pacific Corporation, Anadarko Midstream, Chevron Global Power, ConocoPhillips Gas and Power, Hexcel Corporation, Intermountain Healthcare, IM Flash Technologies, LLC, May Foundry & Machine Company and Simplot Phosphates (“UAE Intervention Group” or “UAE”), hereby petition for leave to intervene in this docket.
