I. GRANTING JOINT MOTION TO EXTEND THE TIME TO RESPOND TO ROCKY MOUNTAIN POWER'S MOTION TO STRIKE PREFILED SUPPLEMENTAL DIRECT TESTIMONY OF J. ROBERT MALKO

This matter is before the Commission on the joint motion of PacifiCorp, doing business in Utah as Rocky Mountain Power, ("RMP") and the Utah Industrial Energy Consumers ("UIEC") filed July 31, 2012 ("Joint Motion"). In the Joint Motion, RMP and UIEC move the Commission for an order extending the time in which to respond to RMP's motion to strike certain pre-filed supplemental direct testimony of J. Robert Malko ("Motion to Strike"). In a previous order, the Commission established July 27, 2012, as the deadline for responses to the Motion to Strike and July 31, 2012, as the deadline for replies. Subsequently, pursuant to a

II. GRANTING SECOND MOTION OF THE DIVISION OF PUBLIC UTILITIES TO AMEND SCHEDULE EXTENDING FILING DATE FOR COST OF SERVICE AND RATE DESIGN REBUTTAL TESTIMONY

This matter is before the Commission on the Second Motion to Amend Schedule Extending Filing Date for Cost of Service and Rate Design Rebuttal Testimony, filed by the Division of Public Utilities ("Division") on August 1, 2012. In its motion, the Division seeks to extend the filing date for rebuttal testimony in the Cost of Service and Rate Design Phase from August 2, 2012 to August 7, 2012. The Division requests the extension to facilitate ongoing settlement discussions.
