# By The Commission:

These matters are before the Commission upon the filing of the Settlement Stipulation (the "Stipulation") on August 7, 2012, by the following parties: PacifiCorp (dba in Utah as Rocky Mountain Power), the Division of Public Utilities, the Office of Consumer Services, Utah Clean Energy, Western Resource Advocates, Federal Executive Agencies, Utah Association of Energy Users, and Kroger Co. (collectively, the "Parties"). Generally, the Stipulation resolves all requests for relief and related issues pending in the three above-captioned dockets. The Parties request the Commission hold a hearing on the Stipulation so that some or all of the Parties may present testimony in support of the Stipulation.

The Commission's Scheduling Order in Docket No. 11-035-200 set hearings in the Revenue Requirement Phase to begin on August 20, 2012, continuing for about two weeks, with a Public Witness Day hearing scheduled for August 29, 2012. Docket Nos. 12-035-79 and 12-035-80 also have established schedules, but they do not call for hearings until later in the year. In light of the broad sponsorship of the Stipulation, we hereby suspend the remainder of the schedules in these three dockets. As the parties request, we will hold a hearing to examine the Stipulation. The hearing will commence at 9:00 a.m. on Tuesday, August 21, 2012, in Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.

#### PUBLIC PARTICIPATION

In order to receive timely public comments on the Stipulation, we hereby reschedule the Public Witness Day hearing, previously scheduled for August 29, 2012.
