



### Appearance Consent and Release

I represent that all statements, assertions and actions of mine in the Material are true and correct to the best of my knowledge and belief, and that nothing I say or do in the Material is defamatory or violative of the rights of privacy of any other person. My participation in the Material does not violate any agreement to which I am bound.

I agree to hold Sponsor and any of its licensees (and sublicensees), affiliates, and assigns and each of their respective present, future and former employees, officers, directors, agents, parents, subsidiaries, consultants, vendors and related companies (collectively, "Releasees") harmless from and against any liability based on any personal, property, residual, re-use or other right which I have or may have by virtue of any such use of my name, voice, likeness or biographical material, or as a result of the exhibition or distribution of the Materials or any portion thereof. In addition, I release Releasees and hold Releasees harmless from and against any claim arising out of any of my acts or statements made in connection with the Materials (including, but not limited to, defamation, invasion of privacy, and the like). I agree that Sponsor may assign this Appearance Consent and Release to any person or entity without limitation.

I agree that I will not have the right to seek injunctive relief to enjoin or restrain Sponsor's exercise of the rights granted in this Appearance Consent and Release. I have granted this consent and release in consideration of Sponsor's permission for me to participate in the recording of the Materials. I certify that this Appearance Consent and Release constitutes the sole, complete, and exclusive agreement between sponsor and/or Producer and myself regarding the Material and Sponsor's use thereof and that I am not relying on any other oral or written representation. I have the full right and legal capacity to sign this Appearance Consent and Release.
