Dave,

2 items on the proposed scheduling order need to be addressed.

The first is the test year issue. We filed a motion for a different test year and UAE filed a request for evidentiary hearing on test year. Those are not reflected in the proposed schedule. Most importantly, if a different test year is granted, there needs to be a time by which RMP has to file the updated information that allows adequate time for other parties to file their direct testimony.

Secondly, could you please indicate that the time limits for responses to discovery requests apply to all discovery requests, including those served before the issuance of the scheduling order.
