- 2. Regarding the "Model Statistics" tab in the Excel spreadsheets labeled "Attach UPCS 1-1" and "Attach UPSC 1-2", please briefly describe the type of statistical model (i.e., regression, simultaneous equation, iterative bootstrapping, etc.) used to estimate the predicted values included in the spreadsheets. Please describe each variable specified within the model along with the Company's rationale for selecting each variable. Please provide the estimated model coefficients along with their associated standard errors, t-statistics, p-values (or the appropriate measures of each inferential parameter's statistical significance).
