The above-captioned matter pertains to a proposed tariff revision filed by Rocky Mountain Power (the "Company") on September 1, 2011. The proposed revision relates to the Company's Schedule 91 Surcharge to Fund the Low Income Lifeline Program. The proposed increase would increase the Schedule 91 surcharge to approximately 0.35% of revenues for rate schedules that are not at the \$50/month cap. The Division of Public Utilities (the "Division") and Office of Consumer Services (the "Office") each filed their respective comments on September 23, 2011, recommending approval of the Company's advice letter. For residential customers the surcharge is proposed to increase by three cents per month, from \$0.23 to \$0.26.

A hearing on this proposed surcharge increase is hereby scheduled for **Tuesday**, **October 4, 2011, at 10:00 a.m., in Hearing Room 451, Heber M. Wells Bldg., 160 East 300 South, Salt Lake City, Utah 84111.** While Advice No. 11-07 requests the new surcharge become effective October 1, 2011, because a surcharge increase is proposed, Advice No. 11-07 is hereby suspended pending the outcome of the hearing.
