This filing submits tariff revisions in compliance with the Commission's Report and Order on Revenue Requirement and Rate Design in this docket dated August 11, 2011.

Dear Ms. Son:

On September 14, 2011, PacifiCorp, dba Rocky Mountain Power, (Company) filed a letter with the Commission, Advice No. 11-09, requesting approval of proposed tariff pages associated with Tariff P.S.C.U. No. 48 of Rocky Mountain Power applicable to electric service in the State of Utah, with an effective date of September 21, 2011. The filing submits tariff revisions in compliance with the Commission's August 11, 2011, Memorandum Decision in Docket No. 10-035-124, including the cancellation of Electric Service Schedule Nos. 25 and 40. The Company also provides an Attachment A and Attachment A Workpaper.

On September 19, 2011, the Company filed replacements for the tariff sheet Electric Service Schedule No. 98, "REC Revenues Credit" (Schedule 98), the Attachment A, and the Attachment A Workpaper. The Company explains it had found two errors in the originally submitted information. The correction to the Attachment A Workpaper resulted in a change in the proposed Schedule 98 from -2.65% to -2.64% for Electric Service Schedule No. 23, "General Service – Distibution Voltage – Small Customer" and it has no impact to the rest of the proposed rates in the compliance filing.

On September 21, 2011, the Utah Division of Public Utilities (Division) filed its review of the Company's September 14th and 19th proposed tariff pages. The Division verifies the tariff pages are accurate and recommends the following minor corrections. First, there is a typographical error in the title of Electric Service Schedule No.1 "Residential Service." Second, original sheet no. 12.2, Electric Service Schedule No. 12, "Mercury Vapor-Partial Maintenance," appears to be

missing the 10,000 Lumen Rating and \$9.08 proposed price. Finally, the fraction "3/4" found in the original sheet 21.2 should be consistently displayed and presented in the same font as that fraction appears in sheets 6.2, 6A.2, 8.2, and 9A.2, among others.

The Division also notes the Company inadvertently filed tariff sheets for Electric Service Schedule No. 4, "Pole Attachments" which had been previously dropped from the general rate case and therefore the Division did not give consideration to these sheets.

Once these tariff changes have been approved by the Commission, the Division states the Company will file a complete new tariff book.

Based on the Company's representations and the Division's review, the Commission approves the September 14th tariff sheets subject to the September 19th correction to Schedule 98, and to the recommended corrections noted by the Division, effective September 21, 2011.
