FILING DATE**

Rocky Mountain Power, a division of PacifiCorp, (“Rocky Mountain Power” or “PacifiCorp”), hereby moves the Public Service Commission of Utah (“Commission”) for an extension of the filing date for the demand-side management annual report (“Report”), currently scheduled annually for March 31. In support of this Motion, Rocky Mountain Power states as follows:

1. The Company does not obtain the information necessary to complete the Report until February of each year. As such, the current annual March 31 filing date is not conducive for completing the Report. Granting a permanent extension to the current filing date of the Report, currently scheduled annually for March 31, until May 1 will allow the Company to review all the information thoroughly and file a complete Report.

2. The Commission previously granted an extension for the 2012 Report on March 22, 2012 in Docket No. 12-035-57. Furthermore, the Company also requested an extension of the due date for the 2011 Report on March 31, 2011 in Docket No. 11-035-74. The Company believes that maintaining the May 1 filing date is reasonable, and does not create any hardship for the parties reviewing the Report.

3. Accordingly, the Company respectfully requests that the Commission extend the annual filing date of the Report from March 31 to May 1 beginning with the Report due in 2013.

WHEREFORE, Rocky Mountain Power requests that the Commission order an extension of the annual filing date for the Report from March 31 to May 1 beginning with the Report due in 2013.
