ORDER

ISSUED: January 15, 2013

By The Commission:

On December 12, 2012, PacifiCorp (“Company”), d/b/a Rocky Mountain Power, filed a motion ("Motion") requesting an amendment to the Commission's October 7, 2009, Order ("Order") in Docket No. 09-035-27¹ which establishes the annual filing deadline of the Company's demand-side management annual report ("Report").

In its Motion, the Company requests the Commission permanently extend the Report's annual filing date from March 31 to May 1, beginning with the next Report due this year. The Company indicates it does not obtain the information necessary to complete the Report until February of each year. As such, according to the Company, the current annual March 31 filing date is not conducive for completing the Report. The Company asserts extending the Report's annual filing date to May 1 will allow the Company to review all the information thoroughly and file a complete Report.

On December 13, 2012, the Commission issued an Action Request to the Division of Public Utilities (“Division”) to review the Application and provide comments by January 11, 2013.

On January 9, 2013, the Office of Consumer Services ("Office") filed comments supporting the Company's Motion. On January 11, 2013, the Division also filed comments recommending approval of the Company's Motion, as filed.

The Division supports the Company's assertion that the Company has difficulties obtaining the necessary information required to meet the current March 31 Report deadline. The Office indicates the Report has become more detailed and comprehensive in scope over time and notes the Commission granted filing extensions beyond the March 31 deadline in each of the past two years. For these reasons, both the Division and the Office recommend the Commission approve the Company's Motion.

We find the Company's explanation and the Division's and the Office's recommendations are reasonable and therefore approve the Company's Motion.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that:

1. The Company's Motion to permanently extend the annual filing date of the Company's demand-side management annual report from March 31 to May 1, as described herein is approved.
