BACKGROUND

Caithness Condominium HOA (the "Complainant") filed a formal complaint against Rocky Mountain Power, a division of PacifiCorp (the "Company"), on June 21, 2012, alleging the Company was failing to honor a prior agreement with the Complainant concerning master metering. See Formal Complaint, filed June 21, 2012. Thereafter, the Division of Public Utilities ("Division") filed a recommendation to dismiss the complaint, and a hearing was scheduled and then postponed at the parties' request. In the meantime, the Company filed a motion to dismiss; however, no action was taken on the Company's motion as the parties attempted to resolve this matter on their own. The parties provided periodic updates to the Commission and, on October 30, 2012, Complainant communicated in an e-mail to the Commission that it wishes "to drop its formal complaint against [the Company]." The Commission takes judicial notice of Complainant's e-mail and, accordingly, dismisses the complaint.
