Comes now Rocky Mountain Power ("RMP" or the "Company") and respectfully requests that the Public Service Commission of Utah (the "Commission") take notice of the January 17, 2013, decision of the Wyoming Public Service Commission denying Sierra Club's Motion for Continuance or Stay of its review of the Company's Application for a Certificate of Public Convenience and Necessity to install selective catalytic

reduction systems at Units 3 and 4 of the Jim Bridger power plant located in Sweetwater, Wyoming until such time as the U.S. Environmental Protection Agency ("EPA") issues its final BART determination for the Jim Bridger coal-fired power plant, which was filed with Wyoming Public Service Commission on December 21, 2012 in Docket No. 20000-418-EA-12, Record No. 13314.

- 1. On December 21, 2012, the Sierra Club filed a Motion for Continuance or Stay (the "Motion") with the Wyoming Public Service Commission in the Company's Wyoming Bridger Certificate of Public Convenience and Necessity Docket, requesting that the Wyoming Public Service Commission stay its review of the Company's decision to install selective catalytic reduction systems at Units 3 and 4 of the Jim Bridger power plant located in Sweetwater, Wyoming until such time as the EPA issues its final BART determination for the Jim Bridger coal-fired power plant.
- 2. The Wyoming Public Service Commission heard Sierra Club's Motion at its regularly scheduled Open Meeting on January 17, 2013.
- 3. After hearing oral argument from all intervening parties, the Wyoming Public Service Commission denied the Motion, and set hearing dates for the Company's Application for a Certificate of Public Convenience and Necessity on March 26-28, 2013.
- 4. Rocky Mountain Power will file a copy of the Wyoming Public Service Commission's Order denying the Motion with the Commission as soon as it becomes available.

WHEREFORE, Rocky Mountain Power requests that the Commission take judicial notice of the Wyoming Public Service Commission's decision denying Sierra

Club's Motion for a Continuance or Stay in Docket No. 20000-418-EA-12, Record No. 13314.
