By The Commission:

This matter is before the Public Service Commission of Utah (“Commission”) upon the filing of the Settlement Stipulation (the “Stipulation”) on February 14, 2013, by PacifiCorp (dba in Utah as Rocky Mountain Power referred to hereafter as “Company”). Parties to the Stipulation are the Company, the Utah Division of Public Utilities, and the Utah Office of Consumer Services (“Parties”). The Company represents not all intervening parties in this docket have signed the Stipulation. The Company also notes its understanding that no intervening party opposes the Stipulation.

The Commission’s scheduling order issued October 18, 2012, in this matter set hearings for March 5<sup>th</sup> and 6<sup>th</sup>, 2013. Given the representations of the Company, we hereby give notice we will hold a hearing to examine and consider the Stipulation. As requested by the Parties, **the hearing will commence at 9:00 a.m. MST, on Tuesday, March 5, 2013, in the Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.**

Parties supporting the Stipulation will make one or more witnesses available to explain and offer further support and evidence for the Stipulation. Other parties may also make witnesses available to explain their respective positions in this matter.
