Re:	Utah FinAnswer Express 2012-2014 Cost-Effectiveness, Medium Carbon Scenario for Participation Scenarios

The tables below present the cost-effectiveness findings of the Utah FinAnswer Express program based on projected 2012, 2013, and 2014 costs and savings estimates provided by PacifiCorp in a spreadsheet entitled "Exec Summary 120211". The Utility discount rate is from the 2011 PacifiCorp Integrated Resource Plan.

Cost-effectiveness was tested using the 2011 IRP 69% east system load factor decrement. The tables provided below list modeling inputs, annual cost and savings information provided by PacifiCorp, and cost-effectiveness results for each program scenario.
