Schedule 110 New Homes Program - Dishwasher Requirements

Enclosed for filing are an original and two copies of proposed tariff sheets associated with Tariff P.S.C.U No. 48 of PacifiCorp, d.b.a. Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, Rocky Mountain Power (the "Company") states that the proposed tariff sheets do not constitute a violation of state law or Commission rule. The Company will also provide an electronic version of this filing to psc@utah.gov. The Company respectfully requests an effective date of September 8, 2012 for these changes.

On May 22, 2012, Rocky Mountain Power (the "Company") filed Advice No. 12-08 with the Commission proposing changes to the Schedule 110 New Homes Program that was approved by the Commission on June 27, 2012. In that filing the Company added the prescriptive measure allowing builders to take advantage of an incentive for high efficiency dishwashers energy factor ("EF") 0.75+ designated as Tier 2 by the Consortium for Energy Efficiency ("CEE"). Subsequent to Commission approval of the proposed program changes the Company has found that it missed a CEE appliance standard revision that took effect in January 2012. In that revision CEE removed the Dishwasher Tier 2 specification and changed the Tier 1 designation to match what was the Tier 2 designation. This means the technical performance requirement stays the same but the naming reference to Tier 2 in the Company's Schedule 110 tariff sheets should be changed from Tier 2 to Tier 1 to align standards with ENERGY STAR specifications.

To remedy this administrative issue the Company proposes filing the attached corrected Schedule 110 tariff sheets.
