ORDER GRANTING MOTION FOR CONTINUANCE

On July 25, 2013, Ellis-Hall Consultants, LLC (“Ellis-Hall”) filed a motion to continue the July 29, 2013 scheduling conference in the above-referenced matters since counsel for Ellis-Hall “is unavailable on July 29, 2013 at 8:30 a.m. because of a previously scheduled pretrial conference in Utah Third District Court. . . . Ellis-Hall’s counsel is available on August 2, 5, or 6, 2013, or on another date that is mutually agreeable to all parties.” Based on that motion, the Commission sent an e-mail on July 26, 2013, seeking a response from all parties by 2:00 p.m. today as to each party’s position on the Ellis-Hall motion. In addition, the Commission requested each party to state their availability to participate in a potentially re-scheduled scheduling conference at 9:00 a.m. or 3:00 p.m. on Friday, August 2nd.

The Division of Public Utilities, Office of Consumer Services, and Rocky Mountain Power, d/b/a PacifiCorp each expressed availability to attend a potentially rescheduled

scheduling conference on August 2nd. However, Latigo Wind Park, LLC (“Latigo”) challenges Ellis-Hall’s motion on several grounds and notes that its counsel as well as Latigo’s representative are both unavailable on August 2nd.

Based on the reasons set forth in Ellis-Hall’s motion, and for other good cause appearing, the Commission grants the motion for continuance.

NOTICE OF CONTINUANCE OF SCHEDULING CONFERENCE

Notice is given that the continuance of the scheduling conference previously scheduled for Monday, July 29, 2013, at 8:30 a.m. is cancelled and is rescheduled for **Thursday, August 8, 2013, beginning at 9:00 a.m.** We note that because Latigo has scheduling conflicts with the proposed date of August 2nd, the Commission is setting this scheduling conference for a date affording all parties nearly two weeks to make arrangements to be present or otherwise represented. The scheduling conference will be conducted on the record by the Commission’s Presiding Officer and will be held in the **Fourth Floor Hearing Room 451, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** Parties should come prepared to discuss a schedule for this docket and any pre-hearing matters affecting said schedule.

Individuals wishing to participate by telephone should contact the Public Service Commission two days in advance by calling (801) 530-6716 or (toll-free) 1-866-PSC-UTAH (1-866-772-8824). Participants attending by telephone should then call the Public Service Commission at one of the numbers posted above five minutes before the conference to ensure participation.
