) SCHEDULING ORDER AND NOTICE O HEARINGS

BACKGROUND

On July 9, 2013, PacifiCorp, dba Rocky Mountain Power ("RMP" or "Company") filed four separate applications for approval of power purchase agreements ("PPA") between PacifiCorp and the following counter-parties: Blue Mountain Power Partners, LLC ("Blue Mountain") (Docket No. 13-035-115); Latigo Wind Park, LLC ("Latigo") (Docket No. 13-035-116); Long Ridge Wind I, LLC ("Long Ridge Wind I") (Docket No. 13-035-117); and Long Ridge Wind II, LLC ("Long Ridge Wind II") (Docket No. 13-035-118). The Commission issued notices of filing and comment period for these dockets on July 10, 2013, requesting interested parties to submit comments on each application on or before August 8, 2013, with reply comments due on or before August 23, 2013.

Pursuant to an action request dated July 10, 2013, the Utah Division of Public Utilities ("Division"), filed recommendations in these dockets on July 11, 2013, requesting the Commission hold scheduling conferences to facilitate the process and resolution of these cases.

To that end, the Commission convened duly-noticed scheduling conferences in these dockets on July 23, 2013.

On July 17, 2013, a representative for Ellis-Hall Consultants, LLC ("EHC") filed confidential information certificates in the Blue Mountain and Latigo PPA dockets. On July 19, 2013, EHC petitioned for intervention in the Blue Mountain and Latigo PPA dockets.

At the July 23rd scheduling conferences for the Long Ridge Wind I and Long Ridge Wind II PPAs, parties agreed to a schedule providing for comments from all parties on August 22, 2013 and reply comments on September 5, 2013. The parties further agreed to a hearing date of September 10, 2013.

At the scheduling conferences for Blue Mountain and Latigo, however, Ellis-Hall Consultants, LLC ("EHC") raised concerns about setting a schedule for the Blue Mountain and Latigo PPA dockets similar to the schedule agreed to for the Long Ridge Wind I and Long Ridge Wind II PPA dockets. When parties failed to reach a consensus on a schedule, the Commission continued the scheduling conference to July 29, 2013, to facilitate the attendance of a court reporter.

On July 25, 2013, the law firm of Wood Balmforth LLC, filed an appearance of counsel and a motion to continue status conference in the Blue Mountain and Latigo PPA dockets. On July 26, 2013, the Commission issued an order granting motion for continuance and notice of continuance of scheduling conference to be held on August 8, 2013.

On July 29, 2013, Blue Mountain and Latigo filed emergency requests to re-set the continuation of the July 23, 2013, scheduling conference to August 2, 2013. To that end, the

Commission issued a notice of rescheduling of continued scheduling conference for the Blue Mountain and Latigo PPA dockets for August 2, 2013.

On August 2, 2013, the Commission continued the scheduling conference for the Blue Mountain and Latigo dockets. At the scheduling conference, parties presented positions on issues that could potentially affect the schedule in these dockets. Blue Mountain, Latigo and the Division advocated for a schedule similar to that set in the Long Ridge Wind I and Long Ridge Wind II dockets. EHC indicated the need for a 90 day schedule to accommodate potential motions and discovery.

Based on the discussion of the parties at the continued scheduling conference, the Commission sets the following schedule for these dockets:
